#### NORTH CARRICK COMMUNITY BENEFIT COMPANY (NCCBC)

North Carrick Community Benefit is a community-based company (No: SC480121) with charitable recognition (No: SC045947). It has been distributing funds from Scottish Power Renewables' Dersalloch windfarm since 2015. The company focuses on the roughly 9,500 people living in the 5 community council areas in North Carrick: Crosshill, Straiton and Kirkmichael as 1, Kirkoswald, Maidens and Turnberry as 1, and then Dunure and Minishant and Maybole as the other 3 areas.

NCCBC is a membership organisation with membership open to anyone who lives in the area. It has around £300,000 available to spend on improvements in North Carrick each year.

Applications can be submitted by any constituted group that delivers benefits for people in North Carrick. Applications will be considered where they deliver new and innovative projects which promote one or more of the following priorities:

- Regeneration of our built environment for general public benefit
- Environmental Protection and improvement
- Provision, maintenance, or improvement of Public Open Space
- Projects which reduce Greenhouse Gas emissions
- Projects which promote more efficient use of scarce global resources
- Education for local residents
- Recreational activities/facilities
- Protection, preservation, or enhancement of important or significant local buildings
- Alleviating poverty





- Providing training or employment opportunities for unemployed individuals or groups
- Health benefits
- Alleviating hardship caused through health, disability, isolation or other disadvantage
- Citizenship, capacity building, engagement, volunteering and support for individuals and communities
- Arts, Heritage, or culture

#### CARRICK FUTURES

Carrick Futures supports community projects in Carrick, South Ayrshire.

The fund supports projects primarily located within or directly benefiting one or more of the six community council areas of Ballantrae, Colmonell & Lendalfoot, Barr, Barrhill, Pinmore & Pinwherry and Girvan & District.

Some funds are also available for projects located within or directly benefiting the wider Carrick area. Priority will be given to applications which also benefit one or more of the main beneficiary communities listed above.

#### What Can Carrick Futures Fund?

Carrick Futures can support charitable activities that support the rural regeneration and sustainability of Ballantrae, Colmonell & Lendalfoot, Barr, Barrhill, Pinmore & Pinwherry, Girvan & District and Carrick.

Awards can support a wide range of costs and activities.

The Board has agreed four strategic aims, which it will use to prioritise proposed projects. These are:

- Improving access to services (in particular public transport)
- Enabling a diverse and sustainable population mix (services for young people and older people, but also activities that help create opportunities for families and working age people to live in the area).
- Improving equality of opportunity (including tackling poverty and disadvantage).
- Contributing to a climate smarter world with sustainability at its core

Applicants must normally fulfil the following conditions to apply to the fund:

- The proposal is for projects or activities consistent with the charitable purposes of Carrick Futures;
- Applicants have a constitution (governing document or set of rules) and are set up on a notfor-private-profit basis. However applicants do not need to be registered charities to apply.





• Applicants must provide their latest set of accounts, signed by an independent third party, and a copy of a recent bank statement.

# **Promise Partnership - Youth Led Grant Programme**

Funding body:	Scottish Government
Maximum value:	£ 75,000
Application deadline:	26/08/2024

Grants are available to local authorities and third sector organisations in Scotland working with children and young people with care experience to give young people an opportunity to put their ideas into action and to Keep the Promise.

#### Background

The Corra Foundation has administered The Promise Partnership on behalf of the Scottish Government since 2021. The Youth Led Grant Programme is a new fund.

The Fund is intended to allow children and young people to have a role in delivering change in line with Scotland's commitment to #KeepThePromise and <u>the Promise Scotland Plan 24-30</u> to ensure care experienced children and young people in Scotland grow up loved and feeling safe and respected.

#### **Objectives of Fund**

The Fund aims to enable children and young people with care experience to have a voice in what matters to them and access to funds to help make change in their communities.

#### Value Notes

Up to 10 one-off grants of £75,000 are available.

Grants will be split in the following way:

- £50,000 to enable children and young people to use their ideas.
- £25,000 to support delivery costs eg, staffing and resources.

#### Who Can Apply

Third sector organisations and local authorities in Scotland can apply.





Applicants must:

- Have a proven commitment to embedding the Promise.
- Demonstrate strong engagement and existing relationships with children and young people with care experience.
- Have close connections to an established youth participation network.
- Have existing staff members in place with time and capacity to start delivering this programme immediately.

Applications are encouraged from organisations with previous experience of supporting communityled grant decision-making.

#### All notes of interest must be endorsed by the Promise Lead in the area.

#### Restrictions

The following are not eligible for funding:

- Service delivery or existing project costs.
- Ideas not identified by children and young people in the care community.
- Ideas which are not in line with the Promise and the Plan 24-30.

#### Eligible Expenditure

The Fund is intended to support projects that matter most to the care community. Funding can be used for one idea or several. Final decisions on which projects and activities will be funded must be made by children and young people, with guidance from the organisation holding the funds.

Eligible projects may include:

- Improving community/statutory spaces and facilities.
- Enhancing services and resources for care-experienced young people.
- Fostering inclusion and participation in community activities.
- Designing and delivering events to raise awareness and challenge stigma.

All funding must be spent by March 2025.

#### How To Apply

The deadline for notes of interest is 26 August 2024 (noon).

Notes of interest will be assessed by the Promise Partnership Decision Makers Panel by 15 September 2024.

### **Fairer Workplaces Fund**

Funding body:	Scottish Government
Maximum value:	£ 50,000
Application deadline:	01/09/2024

Grants to help Scotland's businesses, charities and other organisations adopt fair work practices and implement changes, such as the delivery of workplace training and processes that support flexible working, helping to create and sustain a more diverse workforce.

#### Background

This scheme is funded and administered by the Scottish Government.

#### **Objectives of Fund**

The Fairer Workplaces Fund focuses on delivering new projects that support flexible working practices in Scotland, improving diversity, equality, and inclusion (DEI) within the workplace. Grants are provided to organisations to work mainly with third and private sector employers in Scotland, supporting fair work, including payment of the real Living Wage, and providing an effective voice for workers.

The scheme aims to bring benefits to current workplace practices and contribute to the Scottish Government's wider ambition of creating a Fair Work Nation.

Projects should contribute to reducing the Gender Pay Gap, at least halving the Disability Employment Gap, addressing employment barriers for racialised minorities and over 50s workers, and reducing Scotland's level of economic inactivity.

The fund is rooted in Fair Work principles, ensuring projects help develop progressive workplaces to the benefit of employers, workers, the economy as a whole, and wider wellbeing economy aims.

#### Value Notes

The total available budget for the fund in the 2024 to 2025 financial year is £350,000. A minimum of £75,000 of this is ringfenced for projects relating to flexible working.

Individual applicants may apply for a grant of up to £50,000 per project.





#### Who Can Apply

Applications are open to organisations working with private and third sector employers in Scotland. This is mainly, but not restricted to, small and medium-sized employers (SMEs) and charities. Public sector involvement is permitted only as part of a wider collaborative approach and not with a public sector body as the primary beneficiary.

Applicants need to demonstrate that they are following mandatory Fair Work First principles regarding the Real Living Wage and Effective Voice, unless exceptions apply.

The Grantee must pay the real Living Wage to all staff aged 16 and over working in Scotland, including apprentices. They must also ensure that any UK-based workers engaged in grant-funded activity are paid at least the real Living Wage - including sub-contractors and agency staff, where applicable.

Applicants must be able to demonstrate that their project fits with Scottish Government Fair Work ambitions and related key priorities of government such as:

- Reducing child poverty.
- Reducing economic inactivity.
- Filling labour shortages.
- Reducing the disability employment gap (DEG).
- Reducing the gender pay gap.
- Eradicating structural inequalities.
- Supporting carers.
- Working flexibly.

#### Eligible Expenditure

Funding must be used for new activity or show additional benefits to any previously funded activity relating to Fair Work in the workplace. Expanding existing projects may be considered where prior learning has resulted in a new approach being developed.

Applicants can use the funding to deliver activities such as, training, awareness raising/ campaigns, pilot projects, projects that will improve the existing equalities evidence base, and development and delivery of new processes or practices. However, applicants are not limited to this.

Projects are expected to commence in early October 2024 and must be completed by the end of March 2025. Tangible learning and dissemination deliverables are expected to be central to funded projects.

# Service Women: Seen and Heard Programme

Funding body:	Armed Forces Covenant Fund Trust
Maximum value:	£ 100,000
Application deadline:	25/09/2024

Grants are available for UK registered charities, CICs, and Armed Forces Units to support projects that tackle the underlying issues unique to serving women (including reservists), providing improved access to support for their mental and physical health and wellbeing.

#### Background

The Service Women: Seen and Heard Programme is provided and administered by the Armed Forces Covenant Fund Trust. It is one of the programmes being launched under the Trust's new three-year Covenant Fund Funding Framework.

This programme fits under the theme of ensuring Armed Forces communities are not disadvantaged. It will be both preventative and improve access in relation to mental health & wellbeing.

#### **Objectives of Fund**

The funding is for projects that help towards enabling serving women to make informed choices and improve their access to services that enhance their wellbeing.

The project should look to address the needs of Service women affected by a range of issues which are particular to (or exacerbated by) serving in the Armed Forces, as well as issues where support may be less readily accessible than it is for women in civilian life.

Projects need to meet one of the following outcomes:

- Enabling Service women to choose activities and/or find advice that improves their wellbeing, either preventatively or at times of crisis.
- Opening up choices for Service women who may not otherwise know where to seek help for issues which specifically affect them.

In addition, projects must meet at least one of the programme themes:

• Work-life balance, enjoying and achieving.





- Mental and physical health and wellbeing.
- Support for marginalised and minority women.

These cohorts could include women who:

- Are neurodiverse
- Have additional educational needs
- Are from Black and Minoritised Ethnic communities.
- Are less able to access services due to lack of confidence using social media or online platforms.
- Age and stage of life impacts their ability to access services, such as very young women, those raising children, older women.
- Need support with their sexuality or gender identity.
- Are from rural or isolated communities.
- Are from low-income backgrounds

#### Value Notes

The following grants are available:

- £25,000 to £50,000 towards a project being delivered over a one-year period
- £25,000 to £100,000 towards a project being delivered over a two-year period.

In exceptional cases, an enhanced grant of up to £50,000 to deliver an additional element can be requested for projects of up to two years duration.

One-year projects are not eligible for an enhanced grant.

Projects to start between December 2024 and March 2025.

#### Who Can Apply

Applications will be accepted from:

- Charities registered with one or more of the charity commissions for England and Wales, Scotland or Northern Ireland for at least three years at time of application. They must have at least three unrelated trustees.
- Community Interest Companies (CIC) incorporated in the UK for a least three years and submitted three years of accounts to Companies House at time of application. They must have at least three unrelated directors.
- Armed Forces units/bases that have engaged with, and looking to work in partnership with external organisations who can provide specific services to meet the needs of the targeted group. These do not need to be Armed Forces specific organisations.

Charities and CICs which do not have substantial recent experience of working with the Armed Forces community can apply as long as their project is delivered in partnership with another organisation (or organisations) which have substantial recent experience of working with Armed Forces communities or which are Armed Forces-specific.





#### Restrictions

The following are not eligible for funding:

- Childcare providers (including early years).
- Commercial organisations that would seek for their solution to be provided to a school for profit. For example, an organisation could not be awarded a grant to develop a training course which it then charges schools to attend.
- Schools, including LA maintained and independent schools, regardless of their charitable status.
- Individuals.
- Academy Trusts (cannot apply for an overarching project across their academy chain).
- A charity or CIC which does not have substantial recent experience of supporting Armed Forces communities, unless it will be working in partnership with an organisation that is either Armed Forces-experienced or Armed Forces-specific.
- A charity or CIC which is newly registered.
- A charity or CIC that is based overseas.
- Local authorities.
- Other public sector organisations though they could work with one of the eligible types of organisations as a delivery partner.
- Community organisations that do not fit any of the eligibility criteria, such as a sports organisation which is not a charity or CIC.
- Not-for-profit organisations that are not registered as either a charity or CIC.
- A private or for-profit company

#### Eligible Expenditure

The funding can be used for most things need to run the project or activity, including people's time, costs of delivering work online or buying/hiring equipment. Applicants should consult the guidance notes for a detailed list of what can and cannot be supported.

# **Scottish Enterprise - Workplace Transformation Support Fund**

Funding body:	Scottish Enterprise
Maximum value:	£ 100,000
Application deadline:	Not specified

Grants are available to enterprises in Scotland engaged in key sectors to support the delivery of projects focused on transforming practices, skills and leadership capabilities within the workplace.

#### Background

The Workplace Transformation Support initiative is provided by Scottish Enterprise.

#### **Objectives of Fund**

The funding is intended to deliver support to companies to foster business growth by creating change in key strategic areas. It will support projects that transform workplace practices, skills and leadership capabilities, aiming to increase and accelerate capital investment and maximise returns.

The fund's focus is on key industries of the future, including:

- Clean energy.
- Professional, scientific and technical services.
- Information and communications.
- Manufacturing.

#### Value Notes

The fund has a total value of £500,000.

Grants of between £15,000 and £100,000 are available, to fund up to 50% of eligible project costs.

#### Match Funding Restrictions

Applicants are required to provide at least 50% of their total project costs from other sources.

#### Who Can Apply

To be eligible, applicants must:

- Operate within the area served by Scottish Enterprise (Aberdeen City and Shire, the east of Scotland, Tayside and the west of Scotland).
- Operate in a key industry, such as: manufacturing; professional, scientific and technical; information and communications; or clean energy.
- Have more than 10 employees (unless the business focuses on an area that does not require more than 10 employees).





To qualify for support, the project must:

- Be linked to capital investment of at least £200,000. This must have taken place in the past 12 months or is being considered for the next 12 months.
- Support the transformation of the workplace through the adoption of new practices, skills or training and link directly to the capital investment.

#### Restrictions

Funding will not be offered where the applicant is already committed to the project or where Scottish Enterprise believes that the project would proceed without support from the fund.

Funding cannot be used for expenses unrelated to the project.

#### Eligible Expenditure

Grants are intended to support the delivery of capital investment projects designed to create transformational change within the workplace.

The funding can be used to:

- Develop a fair and innovative work culture.
- Develop leadership and management.
- Support the adoption of new workplace practices.
- Increase skill levels across the organisation through training and support this can include the use of new technology, such as digital, AI or robotics.
- Support the redesign of job roles that improve productivity and support change.

All supported projects must be completed by 31 March 2025.

Applications may be made at any time to support the delivery of projects by 31 March 2025.

# Armed Forces Covenant Fund Trust – Hidden Voices Programme

Funding body:	Armed Forces Covenant Fund Trust
Maximum value:	£ 20,000

Grants are available for UK registered charities and CICs for collaborative projects which address the unique mental health and wellbeing needs of marginalised groups in Armed Forces communities focusing on prevention and early intervention.

#### Background

The Hidden Voices Programme is provided and administered by the Armed Forces Covenant Fund Trust. It is one of the programmes being launched under the Trust's new three-year Covenant Fund Funding Framework.

The programme fits under the theme of ensuring Armed Forces communities are not disadvantaged. It addresses the unique needs of seldom heard cohorts and their access to defined mental health and wellbeing support.

#### **Objectives of Fund**

The funding is intended to enable and deliver accessible mental health and wellbeing support for those with seldom heard needs in Armed Forces communities, with a focus on prevention and early intervention - through collaborative projects between Armed Forces organisations and non-Armed Forces specialist organisations.

The funding should benefit current serving Armed Forces personnel, Reservists (including RFA Royal Fleet Auxiliary), Veterans, and their families, whose needs are seldom heard.

The funding is for projects which meet all of the following outcomes:

- Build collaborative partnerships between Armed Forces organisations and specialist non-Armed Forces organisations.
- Identify and address known and unknown gaps in service provision for the Armed Forces community.
- Provide accessible, preventative and defined interventions (rather than general support for the Armed Forces community).
- Increase knowledge and understanding within mainstream voluntary sector organisations of the unique needs of the Armed Forces community in a demonstrable way and create opportunities for continuing support.

Projects should be focused on supporting either serving or Veteran families who are 'seldom heard', to access defined or bespoke mental health and wellbeing support.

Here 'seldom heard' refers to groups or individuals whose voices, opinions or needs are not frequently or adequately represented in mainstream policies or services. These groups face barriers





to participation and may be marginalised or overlooked in various contexts. It encompasses anyone who is under-served and may have barriers to, or specific needs when accessing support services

Potential beneficiaries may include, for example:

- Black and minority ethnic individuals
- Carers
- People with disabilities
- Members of the LGBT+ community
- Those for whom English is an additional language
- People from Foreign & Commonwealth communities
- Other members of the Armed Forces community with seldom-heard needs that can be overlooked.

#### Value Notes

Grants of up to £20,000 are available for projects being delivered over 12 months.

#### Who Can Apply

Applications will be accepted from:

- Charities registered with one or more of the charity commissions for England and Wales, Scotland or Northern Ireland for at least one year at time of application. They must have at least three unrelated trustees.
- Community Interest Companies (CIC) with substantial recent experience of supporting Armed Forces communities and have been registered as a CIC for more than one year at the time of application. CICs must have been registered in the UK for more than one year and submitted one year of accounts to Companies House at time of application. They must have at least three unrelated directors.

Charities and CICs which do not have substantial recent experience of working with the Armed Forces community can apply as long their project is delivered in partnership with another organisation or organisations with substantial recent experience of working with Armed Forces communities or are Armed Forces-specific.

Applications will be accepted from:

- Specialist non-Armed Forces organisations working with Armed Forces organisations or Armed Forces units or bases for learning or referrals.
- Armed Forces organisations working with non-Armed Forces specialist organisations in partnership.

#### Restrictions

The following are not eligible for funding:

- Childcare providers (including early years).
- Schools, regardless of their charitable status.





- An individual.
- A charity or CIC that is based overseas.
- Community organisations that do not fit any of the eligibility criteria, such as a sports organisation which is not a charity or CIC.
- Not-for-profit organisations that are not registered as either a charity or CIC.
- A private or for-profit company.
- Local Authorities.
- NHS Trusts or organisations delivering statutory services.
- Projects which duplicate existing provision.

The full list of exclusions can be found in the guidance notes

#### Eligible Expenditure

The funding can be used for most things need to run the project or activity, including people's time, costs of delivering work online or buying/hiring equipment. Applicants should consult the guidance notes for a detailed list of what can and cannot be supported.

The funding can support both new projects as well as the continuation or expansion of existing work which offers collaborative approaches to support under-served cohorts. Both local and regional projects are eligible to apply.

Allied Vehicles Group set up the Allied Vehicles Charitable Trust in January 2022. Each month, it allocates £20,000 to the Trust to be used to support charity and community organisations across Scotland.

#### **Objectives of Fund**

The trust supports a wide range of local and national charities across Scotland.

#### Value Notes

Funding is at the discretion of the Trust. Thus far, grants have ranged from £400 to £6,000 per project.

#### Who Can Apply

Local and national charities, voluntary organisations, community groups and schools from across Scotland can apply.

#### **Previous Success**

Examples of grant recipients include:

- Balornock Primary School to fund their whole school summer trips.
- Cadder Community Festival Group to help fund their annual Cadder Gala Day in August.
- Cancer Card, a Scottish charity dedicated to supporting individuals and families affected by cancer, to support their Comfort Box scheme.
- Clydesdale Food Bank
- Homeless Project Scotland.
- SensationALL, a charity dedicated to supporting people with neurodivergent and complex conditions.
- Volunteer Tutors Organisation Ltd (VTO) to support their Learning Hubs in the Possilpark area of Glasgow. VTO provides educational support to children and young people most affected by the poverty-related attainment gap.

#### Eligible Expenditure

The funding is to be used for costs directly related to the project.

The Imperial Community Impact Fund is provided and administered by Imperial Polythene, a UKbased polythene manufacturer.

#### **Objectives of Fund**

This fund aims to encourage and empower local organisations working in the fields of environment, sustainability, creativity, and addressing local problems to deliver projects that enhance the wellbeing of communities and promote sustainable development.

#### Value Notes

A total of £10,000 is available.

Grants of up to £1,000 are available.

# Who Can Apply

The following can apply:

• Charities.





- Charitable incorporated organisations (CIOs).
- Community interest companies (CICs).

Organisations must:

- Have an annual income of between £25,000 and £500,000 in their last set of accounts.
- Have a safeguarding policy (if applicable).
- Have a bank account in the name of the organisation with a minimum of two unrelated signatories.
- Have a board of at least three unrelated trustees or directors.
- Have been operating for at least 12 months and have published financial data available.

#### Restrictions

The following are not eligible for funding:

- Companies limited by shares.
- Friends of associations.
- Branches or federations of national charities.
- Organisations where the primary benefit is the advancement of religion.
- Large organisations that have a greater capacity to fundraise.
- Schools, colleges, or those seeking educational bursaries.
- Uniformed groups such as scouts, guides, and sea cadets.
- Sports clubs and associations.
- Organisations using funds to provide cash grants or vouchers.
- Third-party fundraising.
- Activities that promote political or religious views.
- Purely commercial ventures.
- Retrospective costs.
- Redistribution of a grant to individuals or other organisations.
- Activities where people are excluded on the basis of religion, sexual orientation, sex, or ethnicity.

#### Eligible Expenditure
