Minutes of a hybrid webcast meeting held on 26 October 2023 at 10.00 a.m.

Committee Services Officer; and E. Moore, Committee Services Assistant.

Opening Remarks

The Chair welcomed everyone to the meeting, outlined the procedures for conducting this meeting and advised that it would be broadcast live.

1. Declarations of Interest

There were no declarations of interest by Members of the Board in terms of the Councillors' Code of Conduct.

2. Date of Next Board Meeting

The Chair advised that the next Board meeting would be held on Thursday 23 November 2023 at 10.00 a.m.

3. Minutes of Previous Meeting

The <u>Minutes</u> of the Meeting of South Ayrshire Licensing Board of 21 September 2023 (issued) were submitted.

<u>Decided</u>: to approve the Minutes of the previous meeting.

4. Update by Licensing Standards Officer

The Licensing Standards Officer

- (1) referred to the training event which had been arranged for Thursday 2 November 2023 in Ayr Town Hall to ensure that staff were trained prior to the busy festive period by covering the minimum two hour mandatory staff training for those who did not have a personal licence but worked within licensed premises; and advised that only a few spaces remained for this course:
- (2) thanked David Cuthill, a member of South Ayrshire Local Licensing Forum who had delivered invitations to premises in the Ayr and Prestwick area:

- (3) advised that the liquor licensing legislation required individuals to receive this training from a personal licence holder and for this to be documented and copies retained for inspection;
- (4) outlined that a premises in South Ayrshire had recently come to the attention of the Board for not providing or documenting adequate staff training and ultimately this could lead to a review of the Premises Licence and licence holders could face the potential actions that could be taken as a result of that hearing:
- (5) advised that whilst there was no requirement for a premises licence to be renewed, an annual fee was due by 1 October each year to 'maintain' the licence; that currently the fees were overdue in relation to some venues and that final reminder letters had now been issued with a list of the premises with outstanding fees being provided to the November Board meeting with a request for the Board to suspend the premises licence until the fees had been paid; however, work was ongoing to establish the current trading status of any premises on the list to ensure that no active premises were suspended prior to the busy festive period; and
- (6) that, despite the ongoing rising costs and staffing challenges currently facing the licensed trade, the Licensing Team remained busy with applications and enquiries relating to licence transfers and variations to premises licences as licence holders prepared for the future; and that Occasional Licence applications were still being received for dates this year and in advance for events in 2024.

The Chair

- (a) advised that it was pleasing to note that the free training event was taking place and that this event was almost fully booked;
- (b) thanked the Licensing Standards Officer and David Cuthill for the work undertaken in arranging this event and encouraged Board Members to attend;
- (c) thanked the members of the Local Licensing Forum for their input to the consultation on the Statement of Licensing Policy; and
- (d) recommended that those premises who had not paid their annual fees do so as soon as possible to ensure that they were not disadvantaged over the busy festive period by having their licence suspended.

Decided: to note the Licensing Standards Officer's update.

Subject: Revocation of Personal Licences

1. Purpose

To advise members on the revocations of personal licences.

2. Recommendation

To note the terms of the report

3. Background

The Licensing (Scotland) Act 2005 introduced personal licences. It is a condition of the personal licence that (a) the applicant undertakes refresher training within five years of the date of issue of the licence and (b) no later than 3 months after the expiry of five years from the date of issue produces evidence of the training to the Board. Failure to complete either part of the process means that the Board must revoke the personal licence. (Licensing (Scotland) Act 2005 section 87(3)

4. Current Position

Since the last report to the Board, a further 9 personal licences as per appendix 1 have been revoked under delegated powers. All licence holders affected have been advised by post to their last known address of the revocation of their licences. Revoked licence holders can still take refresher training and then reapply for another personal licence although there is a cost of £50 for the new application. (There is no fee payable if the refresher training is completed and intimated to the Board on time.)

Crooksmoss Bowling Club – Ayr Extended Hours Application – 31st December 2023 Report by Licensing Standards Officer

I refer to the Extended Hours application submitted for the above Club premises which is situated in Glenmuir Place in Ayr.

The application requests a terminal hour of 1.30am on the evening of Sunday 31st December 2023 (extending into the morning of Monday 1st January 2024) and refers to 'an event of local or national significance' namely 'Hogmanay Party' as the reason for the extended hours requested.

The premises currently enjoys a terminal hour of 12 midnight on a Sunday and the application requests a one and a half hour extension to this which is more than can be granted by delegated powers under the board's current policy. They operate as a members club and are on the outskirts of a residential area and are situated behind another licensed venue who will also be permitted later hours on this date.

I understand that the reason for the extended hours is to allow the club members and their families who will be visiting at the time the opportunity to celebrate the new year, which they would be unable to do with the current trading hours.

I would also remind Board Members that this application is for a Members Club and therefore the additional hours, if granted, will only be enjoyed by the members and guests of those members as per the constitution and the event will not be 'advertised' or 'open to the public'.

On this basis I have no objections to the extended hours as requested.

Christopher Morrison – Number 47, Troon Extended Hours Application – 23rd, 24th & 25th November 2023 Report by Licensing Standards Officer

I refer to the Extended Hours application submitted for the above premises which is situated in Templehill in Troon.

The application requests a terminal hour of 3.30am on the evening of Thursday 23rd, Friday 24th and Saturday 25th November (extending into the morning of Sunday 26th November) and the application refers to the 'Winterstorm Rock Weekender Music Festival', which is described by the applicant as 'an event of local or national significance'.

I am aware that premises in South Ayrshire have traditionally and recently, enjoyed extended hours for events happening locally as they anticipated a larger crowd in the area and people staying later as many of these events attracted visitors from out with the area.

The Board will be familiar with the 'Winterstorm' event which is taking place within the Troon Town Hall/Walker Hall. The applicant from Number 47 wishes to take advantage of the anticipated additional crowds in the area and the overspill from those who have attended the main event and there will be a DJ playing each night on the premises until close.

I am aware that 'Winterstorm' has been accepted by the Board in the past as a reason to apply for Extended Hours and can confirm that additional hours were granted to these premises previously with no adverse reports received by Licensing as a result. In addition I can confirm that these premises are permitted an additional hours trading throughout the month of December under the 'seasonal variations' section of the operating plan and therefore patrons and local residents will experience a 3.30am terminal hour from Thursday to Sunday until the end of the year.

An Occasional Licence has been applied for the main 'Winterstorm' event in the Town Hall/Walker Hall for Thursday 23rd, Friday 24th and Saturday 25th November terminating at 12 midnight and Sunday 26th November terminating at 10pm.

As this is an established event in the local area and these premises have previously been granted Extended Hours for this purpose, I have no objections to the extended hours applied for.
