Subject: Public Access Exemption Orders: the 152nd Open at Royal Troon Golf Course

1. Purpose

- 1.1 This report seeks authority to agree a Council response to the public consultation representations and to proceed to make temporary public access exemption orders for areas of land affected by the 152nd Open 2024 at Royal Troon Golf Course.

2. Recommendation

2.1 It is recommended that the Panel:

2.1.1 Notes the outcome of the public consultation on the proposed public access exemption for land at Royal Troon Golf Course, and agrees the proposed Council responses to the representations received, as set out in Appendix 1,

2.1.2 Agrees to make temporary public access exemption orders under Section 11(1) of the Land Reform (Scotland) Act 2003, for land at Royal Troon Golf Course, including sections of the core path SA2 and core path SA6/ right of way SKC 28, as set out in the plans included in Appendix 2.

3. Background

- 3.1 Councils can make orders temporarily exempting specific areas of land from access rights (exemption orders). Government guidance suggests exemption orders should be made for health and safety or security reasons, or to permit the charging of a fee for entry to an event. The Council has made a number of exemption orders to facilitate the staging of major public events. Orders effective for 6 or more days must be the subject of prior public consultation and must be confirmed by the Scottish Ministers.

- 3.2 The 152nd Open 2024 is to be held at the Royal Troon Golf Course from **14th to 21st July 2024**. Royal Troon Golf Club has requested that the Council makes access exemption orders for certain periods to facilitate the set-up, dismantling and staging of the event, in a safe and successful manner, covering the Course itself, as well as the core paths/ right of way which cross it.

- 3.3 The Council's approved Scheme of Delegation delegates power to the Director - Housing, Operations and Development, to make access exemption orders covering periods of less than 6 days. As the proposed orders cover periods of more than 6 days approval is required from this Panel to proceed with making the proposed Orders.

3.4 The Panel of 7th November 2023 agreed to commence a public consultation on the proposed Orders. The consultation took place via: the Local papers; Council Web site; Council Twitter Site; email to Troon Community Council; and notices placed on site at Royal Troon Golf Course. The consultation ran from 8th November to 1st December 2023, and received one objection and 3 enquiries (asking for further information on the access restrictions in place during the periods of the proposed Orders). These responses are set out in Appendix 1, together with the comments from the Planning Service on each response.

4. Proposals

- 4.1 Royal Troon Golf Club has requested that access rights exemptions apply over the land and routes, for the areas and dates specified, indicated on the attached plans forming Appendix 2.
- 4.2 For the periods during which the relevant exemption orders are in force, alternative routes for the core paths/ right of way will be available, except for the core period of 24th June – 29th July, when there will be no public access to the entire golf course (as indicated on the plans forming Appendix 2).
- 4.3 It is considered that the responses received to the public consultation did not raise any issues or concerns that would be sufficient to prevent the Council from making the proposed access exemption orders. The details of the consultation, representations received and proposed Council responses are set out in section 13 of this report.
- 4.4 If Panel agrees to make the access exemption orders, they will be submitted to the Scottish Ministers for confirmation. Assuming the Ministers confirm the Orders, a further public notice (of confirmation) will be published in the local press and on the Council's web site, in compliance with the legislation.

5. Legal and Procurement Implications

- 5.1 The recommendations in this report are consistent with legal requirements (the relevant provisions of the Land Reform (Scotland) Act 2003).
- 5.2 There are no procurement implications arising from this report.

6. Financial Implications

- 6.1 Costs associated with undertaking the public consultation and making the access exemption order can be met from existing Planning budgets but will be recoverable from the Royal Troon Golf Club as event organiser. There will be no ongoing financial commitments arising from this report.

7. Human Resources Implications

- 7.1 There are no human resource implications arising directly from the recommendation of this report.

8. Risk

8.1 Risk Implications of adopting the recommendations.

There is a risk access takers visiting the area may be unaware the Course and core paths/ right of way across it have been exempted temporarily from access rights. This will be mitigated by publishing notices of the exemption orders in the local press and on the Council's web site, and by erecting signage on site.

8.2 Risk Implications of rejecting the recommendations.

Rejecting the recommendation to agree to make the Orders will mean that the orders could not be made, which could jeopardize the staging of the 152nd Open at Royal Troon Golf Course, in 2024. There could also be a health and safety risk associated with not creating the orders, in that members of the public could attempt to access the Course during the golf event. The Club have measures ready to place additional stewards/ security staff on the course, for such an outcome, but this may impact the staging of the event and potentially not mitigate all risk to members of the public.

9. Equalities

9.1 The proposals in this report have been assessed through the Equality Impact Assessment Scoping process. There are no significant potential positive or negative equality impacts of agreeing the recommendations and therefore an Equalities Impact Assessment is not required. A copy of the Equalities Scoping Assessment is attached as Appendix 3.

10. Sustainable Development Implications

10.1 ***Considering Strategic Environmental Assessment (SEA)*** - This report does not propose or seek approval for a plan, policy, programme or strategy or document otherwise described which could be considered to constitute a plan, programme, policy or strategy.

10.2 The recommendation of this report will have no significant environmental benefit or cost.

11. Options Appraisal

11.1 An options appraisal has not been carried out in relation to the subject matter of this report.

12. Link to Council Plan

12.1 The matters referred to in this report contribute to the Council strategic objective of 'Maximising the Potential of our Local Economy and within that to the outcome 'tourism, culture and heritage opportunities are developed and promoted.

13. Results of Consultation

13.1 Public notice of the Council's intention to make the proposed access exemption orders and the opportunity to make objections or representations, was published in the local press and on the Council's website. Notices were also posted on-site at various points of the golf course. The consultation was advertised on the Council's social media accounts. Troon Community Council was contacted directly and invited to comment on the proposals. The South Ayrshire Local Access Forum was consulted directly on the proposed exemption orders; the Troon Community Council and the Local Access Forum asked for some additional information, regarding the impact on the Ayrshire Coastal Path, but did not submit an objection to the proposed Orders.

13.2 Councillors Alec Clark and Brian Connolly, as Portfolio holders for Tourism, Culture & Rural Affairs, and Golf, respectively, were consulted and have expressed no objection to it.

13.3 Representations: one objection was received, relating to the closure of the path around the edge of the South Beach car park for the core period of 5 weeks. They stated that this was an unreasonable length of time and would cause disruption to their weekly local event (which uses the path as part of their Parkrun route). Also complained that not enough effort was made to engage with the public, regarding the access restrictions proposed.

A further 3 enquiries were received, asking for more information/ clarification on the access restrictions included in the proposed Orders; this information was provided to the enquirers, as laid out in Appendix 1.

13.4 The Council's proposed responses in Appendix 1 note that the Council considers that the proposed Orders comply with the Land Reform (Scotland) Act 2003 and are necessary and appropriate as a temporary measure, to allow the hosting of the event.

14. Next Steps for Decision Tracking Purposes

14.1 If the recommendation above is approved by Members, the Service Lead Planning & Buildings Standards will ensure that all necessary steps are taken to ensure full implementation of the decision, with the completion status reported to the next Regulatory Panel.

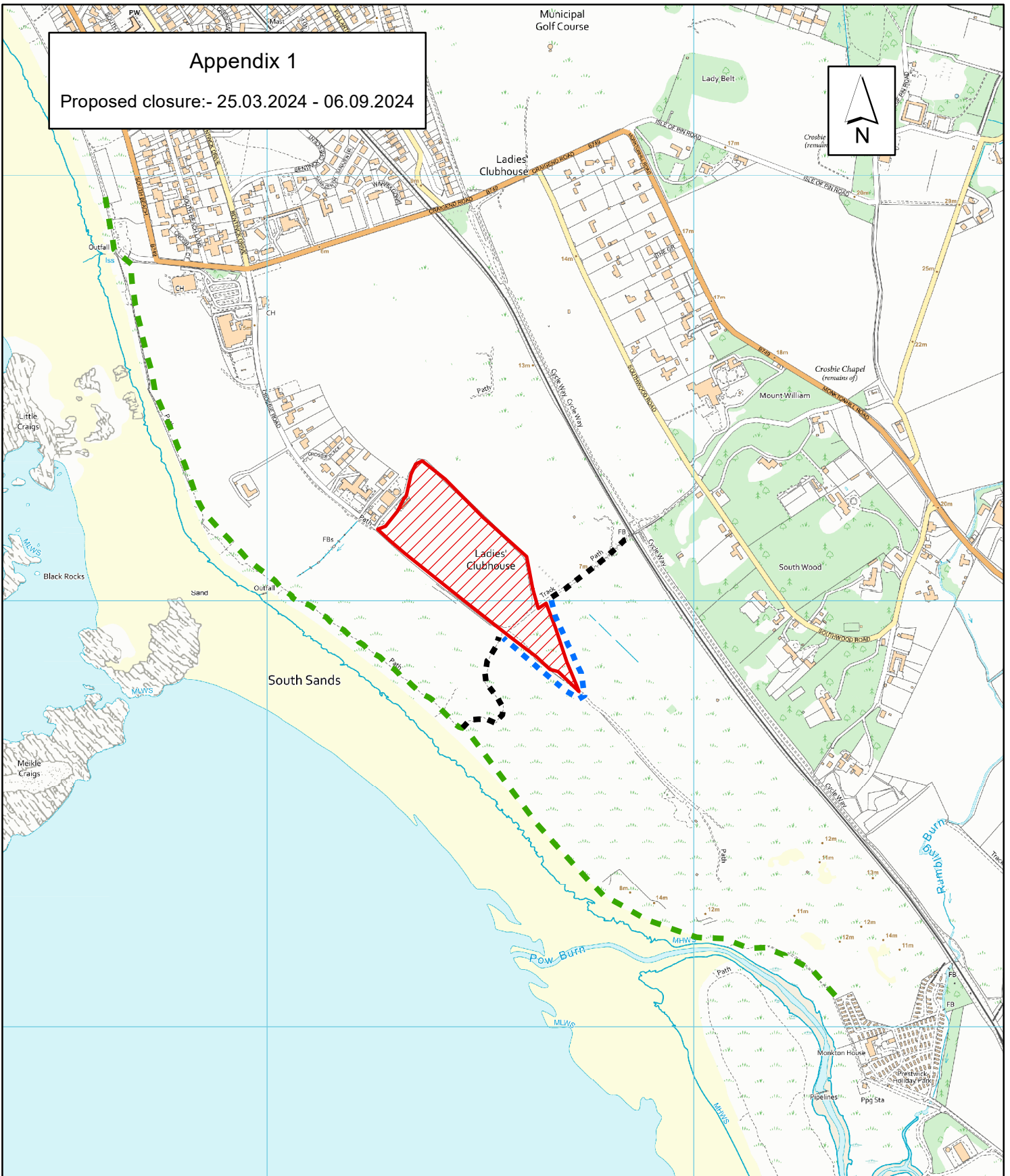

Is it because it's within the Royal Troon boundary which someone has suggested is out to the high water mark on the beach?</p>	<p>1) The Craigend Road and South Beach roads will not be covered by the section 11 access exemption order. However, traffic will likely be heavy on these roads during the event and the construction/dismantling of the temporary structures.</p> <p>2) A section of Ayrshire Coastal Path is on the edge of the golf course boundary. Concerned that the SAC Core Path Plan Maps still shows the route of the Ayrshire Coastal Path (1) running along the top of the Dunes within the confines of the Royal Troon Golf Course grounds from Prestwick Holiday Park to the start of South Beach Road at Troon - when in fact (apart from the first 300m from the Holiday Park to the mouth of the Pow Burn, the ACP route runs along the Crown Property sandy foreshore right to Troon and does NOT encroach on RTGC.</p> <p>2. SAC appears to be using inaccurate maps where the ACP route and Core Plan delineation are different - and this has caused public and business confusion around planning applications on a number of occasions.</p> <p>3. The Heras Fencing erected (and dismantled) before the 2016 Open - along its previous site, Royal Troon GC have recently erected a stout boundary fence from the Holiday Park alongside much of the 300m route of the Coastal Path to Pow Burn, (with the footpath running outwith the course area), which we have understood from Royal Troon GC officers to be part of planning for the 2024 Open. Regarding the Ayrshire Coastal Path on Troon beach: the R & A wishes to divert it by approx. 10 – 30m to the west, along the beach, during the core period of the Championship. The R & A has requested this to create a 'security buffer zone', due to concern raised by instances of protesters attempting to disrupt other high profile events, in the last year or so.</p> <p>2. The Core Path SA2 does not coincide exactly with the Ayrshire Coastal Path at several sections – the mapping is not inaccurate, rather they are different routes. To change the alignment of the core path would require a review of the complete Core Paths Plan, which has not yet been scheduled.</p> <p>3. Following conversations with the R & A about the section of Ayrshire Coastal Path just to the north-west of the Prestwick holiday park it was agreed that the ACP can remain open at this section, with the method of fencing off this section of the path on the landward side of the path. The new sturdy fencing which now runs alongside this section of the ACP may be temporarily reinforced with Heras fencing for the event.</p>

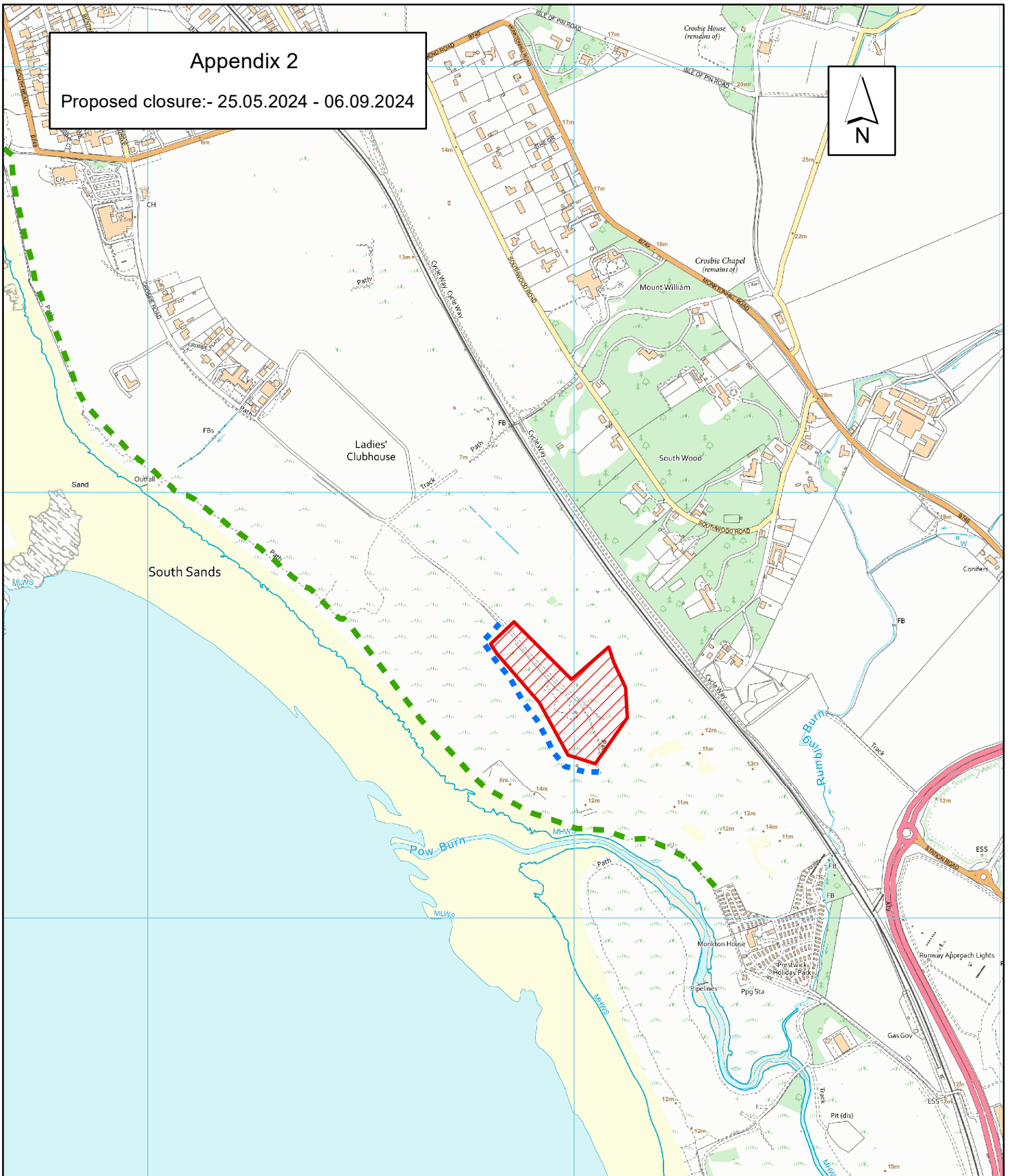

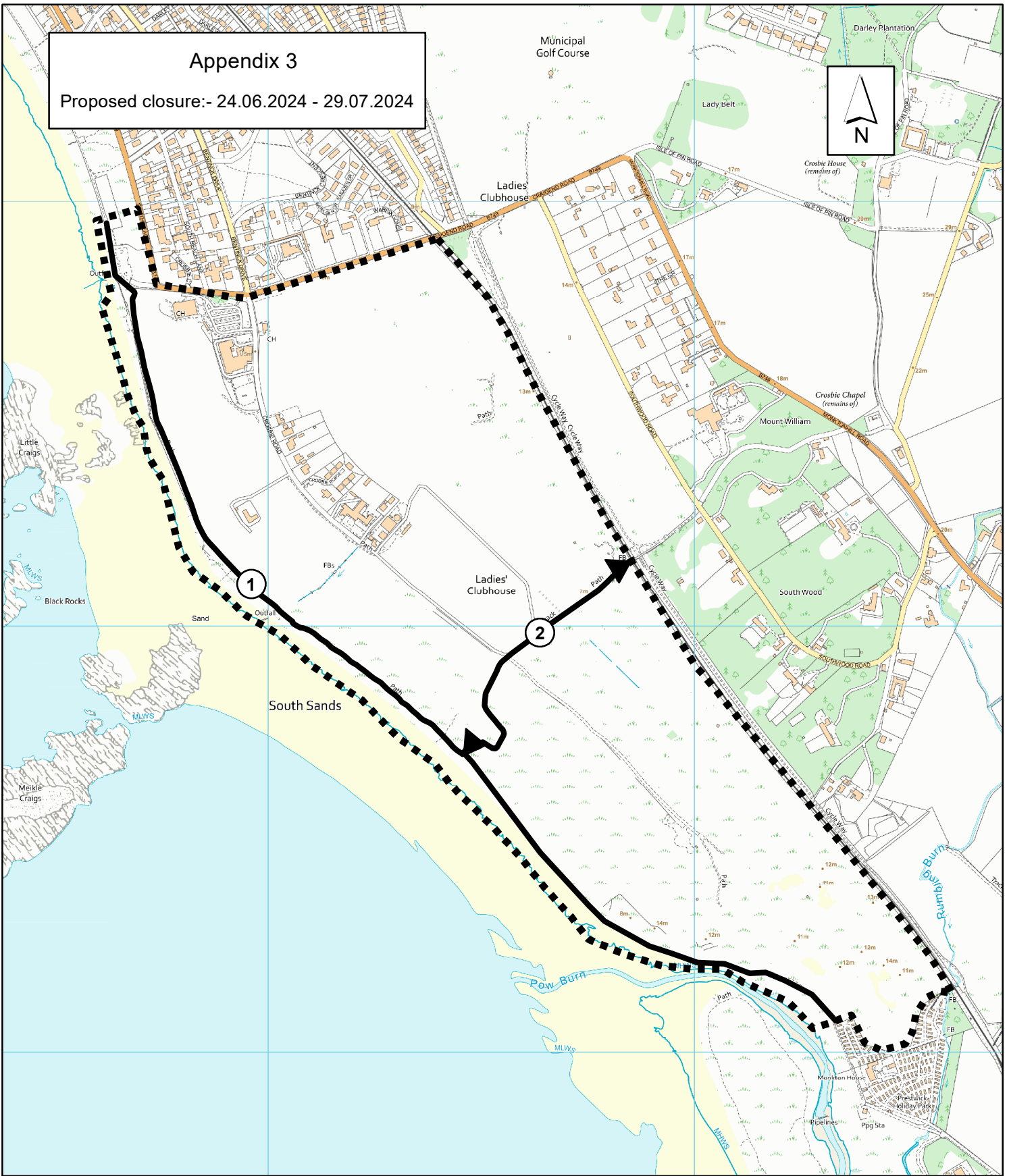

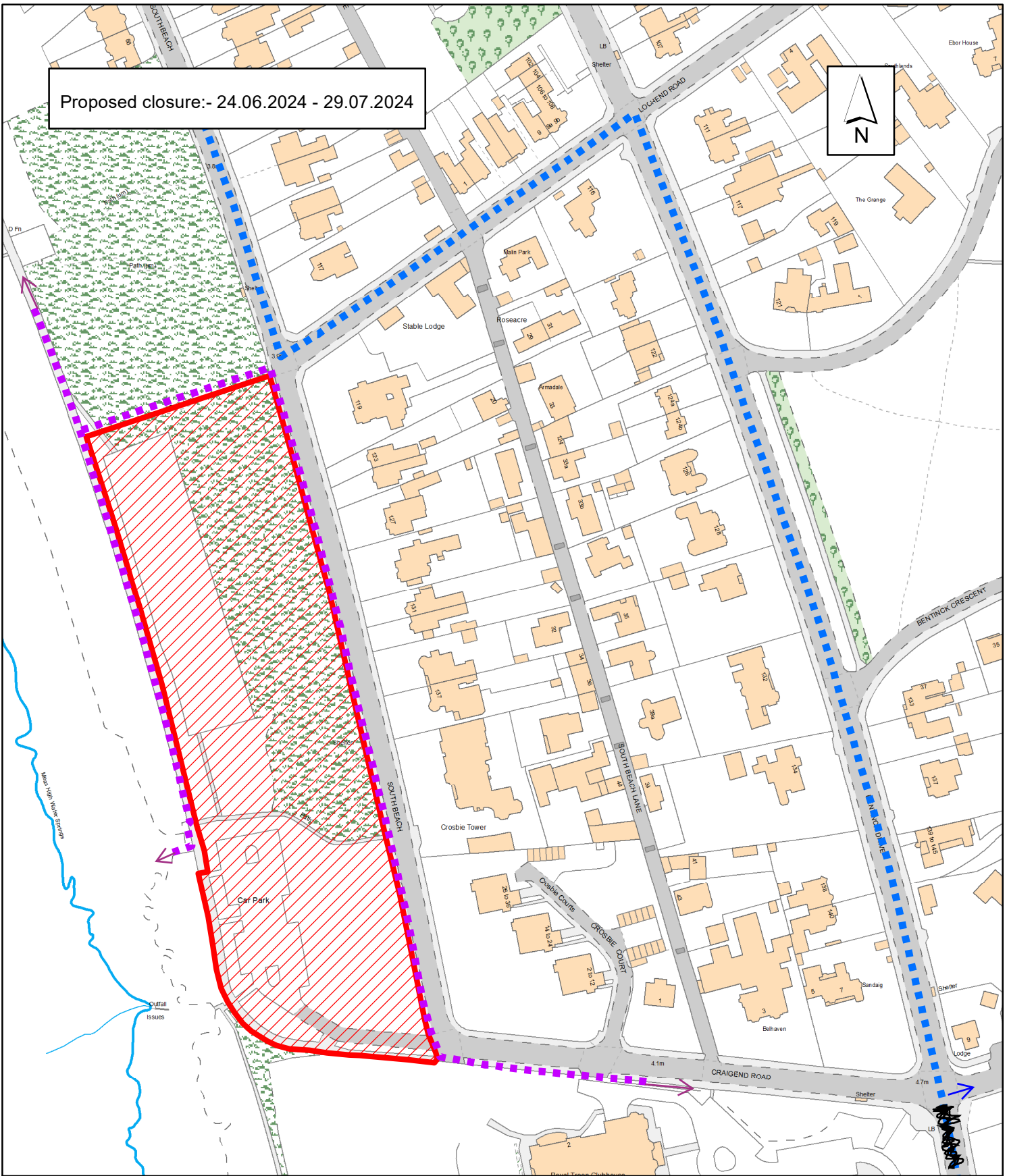

Subject: Public Access Exemption Orders: the 152nd Open at Royal Troon Golf Course (South Beach car park).

1. Purpose

- 1.1 This report seeks authority to undertake a public consultation, regarding proposed temporary public access exemption order for the area of land affected by the 152nd Open 2024 at Royal Troon Golf Course.

2. Recommendation

2.1 It is recommended that the Panel:

- 2.1.1 Approves the commencement of a public consultation on the proposed temporary public access exemption orders under Section 11(1) of the Land Reform (Scotland) Act 2003, for land at the South Beach car park, Troon, adjacent to Royal Troon Golf Course.**

3. Background

- 3.1 There exists a public right of responsible access to most land in Scotland, including golf courses, but with the exception of golf greens. The right of responsible access is exercisable over Royal Troon Golf Course (the Course) and South Beach car park. A footpath/ cycle path runs around the western edge of the car park.
- 3.2 Councils can make orders temporarily exempting specific areas of land from access rights (exemption orders). Government guidance suggests exemption orders should be made for health and safety or security reasons, or to permit the charging of a fee for entry to an event. The Council has made a number of exemption orders to facilitate the staging of major public events.
- 3.3 The 152nd Open 2024 is to be held over the Course from 14th – 21st July 2024 inclusive. The R & A has requested that the Council makes an access exemption order to facilitate the safe and successful setting up & dismantling of temporary structures, for the 'media centre' at South Beach car park, to be used during the staging of the event. The period for which the exemption is sought exceeds 6 days in duration.

- 3.4 Orders effective for 6 or more days must be the subject of prior public consultation and must be confirmed by the Scottish Ministers.
- 3.5 The Council's approved Scheme of Delegation delegates power to the Director - Housing, Operations and Development to make access exemption orders covering periods of less than 6 days. As the proposed orders in this case cover periods of more than 6 days, approval is required from this Panel for public consultation on the proposed orders.

4. Proposals

- 4.1 The R & A has requested that access rights exemption applies over the land and South Beach car park, for the dates 29th April to 30th August 2024 inclusive, the area as indicated on the attached plan shown in Appendix 1.
- 4.2 For the majority of the period during which the relevant exemption order is in force, the footpath/ cycle path around the edge of the car park will be available for public use (as indicated on the plan in Appendix 1). However, during the core dates of the event (24th June – 29th July 2024 inclusive), this footpath/ cycle path will be closed to the public and a diversion will be available to the north of South Beach car park (as indicated on the plan in Appendix 1).
- 4.3 After the expiry of the period for public consultation (the Local Access Forum, Troon Community Council and the portfolio holders for Tourism and Golf, will also be consulted), Panel will be asked to consider any representations made on the proposed Order and for their agreement to make the Order. The access exemption order will then be submitted to the Scottish Ministers for confirmation. Assuming the Ministers confirm the Order, a further public notice (of confirmation) will be published in the local press and on the Council's web site, in compliance with the legislation.

5. Legal and Procurement Implications

- 5.1 The recommendations in this report are consistent with legal requirements (the relevant provisions of the Land Reform (Scotland) Act 2003).
- 5.2 There are no procurement implications arising from this report.

9.1 The proposals in this report have been assessed through the Equality Impact Assessment Scoping process. 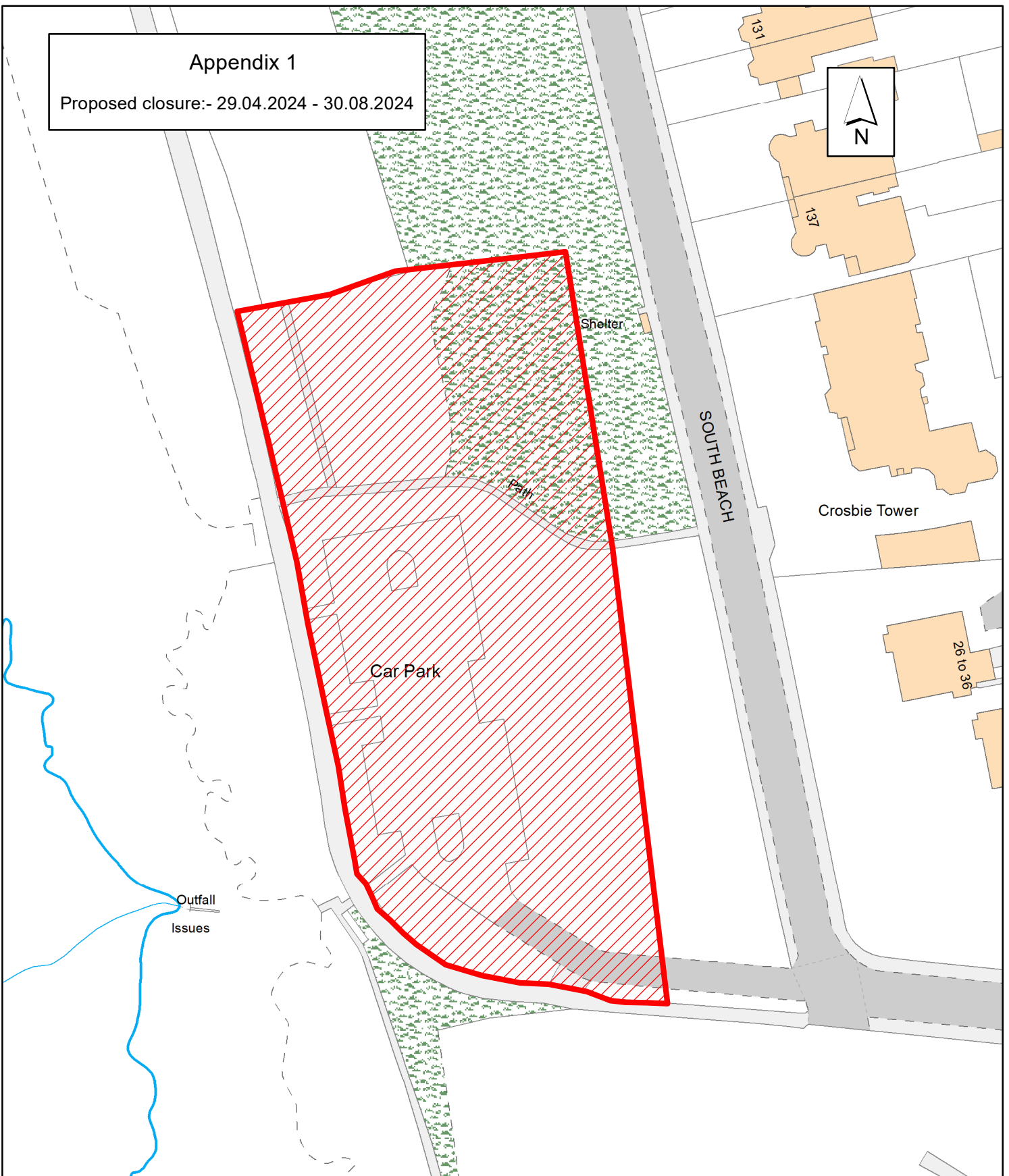
