Common Good Consultation Feedback

Feedback and response on Statutory Consultation with the Local Community under Section 104 of the Community Empowerment (Scotland) Act 2015, for the sale of Girvan Bandstand, Stair Park, Henrietta Street, Girvan to Adventure Centre for Education (ACE), a registered Scottish Charity SC041556.

The Common Good Consultation for Girvan Bandstand, Stair Park, Henrietta Street, Girvan was open between 9am on Monday 11th September 2023 and 5:00pm on Monday 6th November 2023. A notice regarding the consultation was erected at the site in Stair Park, another was displayed in Girvan Library and it was hosted on the South Ayrshire Council website at https://www.south-ayrshire.gov.uk/article/60398/Common-Good-Consultation-Girvan-Bandstand-Stair-Park-Henrietta-Street-Girvan. Details of the consultation were circulated to Girvan Community Council and to other known community organisations with a possible interest in the property. Elected members for the Girvan and South Carrick ward were also notified.

As detailed in the table below, 200 completed representations were received – 198 from individuals and 2 on behalf of organisations. All representations were For (supportive of) the proposal or Neutral. No representations were Against the proposal.

Taking these representations into account, the Cabinet of South Ayrshire Council at its meeting on 28th November, re-confirmed its decision to proceed with the disposal. The next stage in the process is for a petition to be submitted to the Sheriff Court, by South Ayrshire Council, to request authorisation for the proposed sale of Common Good property. That work is underway now.
