Report by Chief Executive to South Ayrshire Council of 29 February 2024

Subject: Review of Polling Arrangements

1. Purpose

1.1 The purpose of this report is to seek Council approval of the scheme of polling arrangements for parliamentary and local elections following review.

2. Recommendation

2.1 It is recommended that the Council:

- 2.1.1 approves the scheme of polling arrangements for parliamentary and local elections as detailed in Appendix 1;
- 2.1.2 agrees to the publication of the polling arrangements and the responses to the Consultation; and
- 2.1.3 grants delegated authority to the Chief Executive, in his role as Returning Officer, to amend the scheme of polling arrangements for parliamentary elections in the event of unforeseen circumstances, where such amendments, if not made, would impede the process of voting for electors.

3. Background

- 3.1 The Electoral Registration and Administration Act 2013 compels local authorities to start and complete a review of polling districts and polling places within a period of 16 months on a five yearly basis. The current compulsory review should be started and completed within the period 1 October 2023 and 31 January 2025.
- 3.2 The Council has continually kept under review its polling districts and polling places to ensure that they remain adequate and appropriate and interim reviews have been held as required.
- 3.3 At its meeting on 6 October 2011, the Council agreed to request that officers identify premises as polling places that were not used for educational purposes, and to give due consideration to access issues, which is a legal requirement and is also contained in the Electoral Commission Guidance on undertaking a review. A revised scheme of polling arrangements was approved by Council on 27 June 2019 which retained some schools as polling places where no suitable alternative premises could be identified or retained.

- The Council is obliged to publish its decision (including reasons for selection of premises proposed) and the responses to its Consultation. There is an appeals process to the Electoral Commission which may be made by thirty or more registered electors (except electors registered anonymously), a person (except the Returning Officer) who made representation to the Council when the review was being undertaken and any person who is not an elector in a constituency in the Council's area but who the Commission thinks has sufficient interest in the accessibility of disabled persons to polling places in the area or has particular expertise in relation to the access to premises or facilities of disabled persons. There are only two grounds on which an appeal may be made:
 - 3.4.1 the Council has failed to meet the reasonable requirements of the electors in the constituency; and
 - the Council has failed to take sufficient account of accessibility to disabled persons of the polling station(s) within a polling place.
- 3.5 An appeal based on any other grounds will not be considered by the Electoral Commission. The current review has been carried out in terms of the guidance issued by the Electoral Commission for polling reviews and using the criteria agreed by the Council. All proposed premises will be accessible for voters with disabilities and will comply with the relevant legislation and guidance.
- Local Elected Members were consulted on the proposals for consideration and positive feedback was received. The polling places and districts used at the 2022 Local Government Elections as amended for required alterations due to unavailability of polling places were used as the basis for consultation which took place between 16 November and 21 December 2023 The Returning Officer Submission which detailed the proposed changes is attached as Appendix 2.
- 3.7 Information on the review was sent to Elected Members, Members of Parliament, Members of the Scottish Parliament, Political Parties, Community Councils, Disability Groups and the Voluntary Association for South Ayrshire. A copy of the Notice of Review was displayed at Headquarters and at Troon, Prestwick, Maybole and Girvan libraries to give the opportunity to comment on the proposals. Full details of the review were available on the Council website.

4. Proposals

- 4.1 The proposed scheme of polling arrangements for parliamentary and local elections is detailed in Appendix 1.
- 4.2 Where schools have been designated as polling places, in-service days will be set to coincide with known electoral events. In the event of an unplanned election event the schools identified can continue to operate although some classes may require to undertake a visit that day, the costs of which can be met from funds set aside for the election/ referendum. This proposal, if approved, would use 47 premises as polling places including 12 schools/ nurseries. The proposals before members are therefore the best available alternatives avoiding school closures, and having regard to suitable available premises in each polling district. The Council can however undertake a further interim review of polling places at any time should the need arise.

- 4.3 These proposals, if approved, would come into force on 1 March 2024 and would incorporate minor polling district changes that are proposed as part of this review. In Ward 3, Ayr North, there are a couple of proposed polling district boundary changes in recognition of the new houses on the former Mainholm Academy site. The boundary for polling district Ayr Dalmilling (S 307) will be extended to include the houses on the former Mainholm Academy site, and a number of voters currently within polling district Ayr Newton South and Braehead (S 304) where the boundary will move to the middle of Whitletts Road., This would result in a small number of voters voting at Dalmilling Primary School as opposed to Lochside Community Education Centre (see Appendices 2 and 3). Electors also have the option to apply to be treated as an absent voter if they would prefer, and further publicity of the option for a postal vote will be carried out.
- 4.4 Following approval, the Scheme of Polling Arrangements requires to be published, together with the Consultation responses, and reasons for the decision taken. It is proposed that these be published on the Council's website and made available for inspection at County Buildings.
- 4.5 There may be circumstances (for example, fire, flooding, vandalism, etc) when a change of polling place is required at short notice. In order to ensure that a speedy response can be made to such circumstances and the poll delivered, it is proposed that the Chief Executive, in his role as Returning Officer, be delegated authority to amend the Scheme of Polling Arrangements for Parliamentary and local elections in the event of unforeseen circumstances, where such amendments, if not made, would impede the process of voting for electors.

5. Legal and Procurement Implications

- 5.1 The Council is obliged, in terms of the Electoral Registration and Administration Act 2013, to review polling districts and polling places between 1 October 2023 and 31 January 2025 and to publish its decision.
- 5.2 There are no procurement implications arising from this report.

6. Financial Implications

6.1 The cost of using polling places for all elections (except South Ayrshire Council elections) and referendums is claimed as part of the election/ referendum costs from central government.

7. Human Resources Implications

- 7.1 Not applicable.
- 8. Risk

8.1 Risk Implications of Adopting the Recommendations

8.1.1 There are no risks associated with adopting the recommendations.

8.2 Risk Implications of Rejecting the Recommendations

8.2.1 Rejecting the recommendations would give rise to a breach of statute.

9. Equalities

9.1 The proposals in this report have been assessed through the Equality Impact Assessment Scoping process. There are no significant potential positive or negative equality impacts of agreeing the recommendations and therefore an Equalities Impact Assessment is not required. A copy of the Equalities Scoping Assessment is attached as Appendix 4.

- 13.3 Consultation has taken place with all Ward Members.
- 13.4 Consultation has taken place with the Electoral Registration Officer.

14.1 If the recommendations above are approved by Members, the Chief Executive will ensure that all necessary steps are taken to ensure full implementation of the decision within the following timescales, with the completion status reported to the Cabinet in the 'Council and Cabinet Decision Log' at each of its meetings until such time as the decision is fully implemented:

South Ayrshire Council Review of Polling Districts and Polling Places 2023 Returning Officer Submission

- South Ayrshire Council is undertaking a review of polling districts and polling places as required by the Electoral Registration and Administration Act 2013. The review is carried out by the Council in accordance with legislation and guidance issued by The Electoral Commission.
- 2. The purpose of the review is to ensure that all electors within South Ayrshire have such reasonable facilities for voting as are practicable and to ensure that as far as possible the accessibility needs of people with disabilities have been considered and met when designating polling places.
- 3. The polling district refers to the geographical area, while the polling place is the building where electors cast their vote. The polling places and districts used at the Local Government Election in May 2022 have been used as the basis for this consultation. The vast majority of polling places identified within the review have been used for many years and no issues have been identified. However, following a review and consideration of alternative locations it is proposed that 2 polling places are changed to alternative locations.
- 4. In making comments on these polling places and districts, I have considered feedback from the election team, from staff working at these polling places, from voters, candidates, agents and from the general public.
- 5. All of the polling places listed have been evaluated in accordance with Electoral Commission Guidance as to their suitability having regard to location, size, accessibility and availability. Consideration has also been given to ability to accommodate multiple polling stations where necessary.
- 6. The legislation specifies that local authority schools may be used free of charge as polling places. Schools are often centrally located in communities, accessible via public transport and able to provide disabled parking. Where schools are designated as polling places, and the poll is scheduled within a fixed term calendar, polling day is designated as an In-Service day to minimise disruption. When a poll is unscheduled, arrangements are put in place to ensure that where possible, schools are able to remain open.

Proposals

7. As Returning Officer, I confirm that I am in agreement with the proposed polling places, and polling district changes as summarised below, on the basis that these proposed alternatives are designed to benefit voters and those undertaking polling duties.

• Ward 1 – Troon

No changes proposed.

Ward 2 – Prestwick

St Ninian's PS is no longer available as a polling place following the creation of the Prestwick North Education Campus. It is proposed that the polling place is now located in Prestwick North Education Campus. There will be no requirement to close the school in the event of an unplanned election.

Ward 3 – Ayr North

No changes proposed to polling places are proposed however it is proposed to redraw polling district boundaries as follows:

- The boundary for polling district S304 will terminate in the middle of Whitletts Road and the following properties will move to polling district Ayr Dalmilling (S307):
 - Braehead Avenue 36 Properties
 - Braehead Crescent 10 Properties
 - Gemmell Court 12 Properties
 - Gemmell Crescent 21 Properties
 - Whitletts Road 4-54 26 Properties

The boundary for polling district Ayr Dalmilling (S307) will be extended to include the houses being built on the former Mainholm Academy site and the properties currently within S304 (as detailed above)

• Ward 4 – Ayr East

The Church of Jesus Christ of the Latter Day Saints Hall is no longer available as a polling place and it is proposed that Kyle Academy is now used. There will be no requirement to close the school in the event of an unplanned election.

Ward 5 – Ayr West

No changes proposed

• Ward 6 – Kyle

No changes proposed.

• Ward 7 – Maybole, North Carrick and Coylton


