- 2. Apologies Max Agnew
- 3. Members of the public present Grant McKenzie G McKenzie was present as he is concerned about the speeding on Culzean Road and also the state of Culzean Road and Belmont Terrace as repairs are being done patch over patch. He has tried unsuccessfully to log a concern on the A.R.A. webpage and has been unsuccessful trying to phone them. G McKenzie was offered the opportunity to stay for the meeting but opted to leave

A.R.A. should be invited to a future meeting to discuss contacting them and also to be shown how to complete the form.

- 4. Declaration of interests None.
- 5. A.O.C.B.Secretary Election RB will take this post temporarily. Proposed MF, seconded SM.

Town Hall refurbishment – see Councillors report.

- 6. Police were present at the meeting. Maybole is the worst area for speeding and driving. Special constables are working in this area. Concern was shown over a trail motorbike being on the road without lights. Cars parking on pavements was discussed. This responsibility lies with South Ayrshire Council, police should only be contacted when there is an obstruction. Local Police can be contacted via e-mail northcarrick@scotlandpolice.uk.
- 7. Approval of Minutes proposed H Whitefield seconded R Birnie.
- 8. Matters arising
 - i. e-mail sent to Paul Dougall, no response as yet.

- ii. £12K CPFfunding should be discussed at the April meeting and members asked to recommend projects of significant impact.
- iii. Graffiti project now starting at the skatepark. There are benches at Gardenrose school which could be used at the skatepark. T Burns, Estates Department at South Ayrshire Council should be contacted.
- iv. F Ross to be contacted to see if Maybole could get more flowers in the centre of the town as we will be celebrating the Bruce event in July.
 - v. Ladywell Terrace Community Payback team to be contacted to see if they can tidy up this area which overlooks the football stadium.
- vi. Community Association now have a new committee which hopefully will work with the Bruce Event for this year.

9. Car Parking

Car parking remains a hot topic. Concerns have been shown regarding the plans for the High Street that there will only be loading bays. Blue badges can only park in a loading bay if there are specific times stipulated for unloading. Following the recent consultation regarding the design feedback has been mainly positive with a general feeling of get on with it. Town Regeneration

Every property has been offered an opportunity to get work done on their building, work can only be done on properties i.e. flats when all owners agree for work to be done and this meant some multi tenanted blocks couldn't proceed. For many reasons owners couldn't engage in the project. A window has fallen out of a derelict building onto the High Street councillors will contact Building Control for an enforcement notice. This building should be blocked off to prevent any further accidents. A new officer has been appointed to manage the project since Duncan has left.

Housing

Police are monitoring houses where people are known to have health issues.

<u>Public safety</u> – window discussed within Town Regeneration.

<u>Planning</u> – planning application for the Cadets House on Kirkoswald Road to make a new back entrance. Concerns were shown that people could cross through going to the school. This will not happen as Cadet house will have its own perimeter fences.

<u>Health & Social Care Partnership</u>— Nothing to report, remove from the agenda.

10.South Ayrshire Councillors

- i. South Ayrshire Council budget has now been approved. Further information available on the South Ayrshire Council website.
- ii. Refuse bins will continue to be removed for those with disabilities.
- iii. Coffee events will be held in local libraries.
- iv. Golf courses have achieved their targets.
- v. Concern was expressed that someone had taken ill in the Town Hall and no-one could find the janitor. Following the Town Hall refurbishment, the Defib was found in a cupboard but not plugged in. Thankfully it was active. MF explained that defibs do not require plugging in it is only external cabinets that require power to reduce condensation and battery depletion due to cold weather. The defib needs to be on show and accessible. BC will report this the South Ayrshire.
- vi. The Council are still using the Customer Service Office on a Friday and the old Social Work office is used by Thriving Communities.
- vii. Bus stops a request was made for a bus stop to be put at the cemetery for the residents in the new estate and also for convenience for people visiting the cemetery who come by bus.
- viii. The new 30mph signs should be placed shortly on Crosshill Road and will be positioned half way up the hill.

11. Community Learning Development

- i. There will be detached Youth working during the Easter Holidays.
- ii. The hub is now open in Whitehall.
- iii. Easter programme is for P7's and a graffiti project will be held at the skatepark. There will be a drop in at the hub on the Wednesday afternoon and Friday nights. There is also a voice group which meets on a Wednesday. A poster will be made to show the dates.
- iv. The p7 Youth Club on a Tuesday night has been well attended. The youth club for secondary pupils will also be starting on a Tuesday night from 7.45pm until 9pm.
- v. Bruce events Gatherings will be open to have a colouring competition in the summer, week leading up to main event.
- vi. SG has visited the school to do heraldry events.

- vii. It was felt that more advertising requires to be done not only in Maybole but the whole of North Carrick.
- viii. Youths are complaining that the hub is not open at weekends and when it is open closes at 8pm.

As this is a youth led hub, young people should decide, is the feedback we have received.
