Minutes of a hybrid webcast meeting of 25 April 2024 at 10.00 a.m.

Chair's Remarks

The Chair

- welcomed everyone to the meeting; and
- (2) outlined the procedures for conducting this meeting and advised that this meeting would be broadcast live.

1. Sederunt and Declarations of Interest.

The Co-ordinator (Licensing) called the Sederunt for the meeting and having called the roll, confirmed that there were no declarations of interest by Members of the Panel in terms of Council Standing Order No. 17 and the Councillors' Code of Conduct.

2. Minutes of Previous Meeting

The minutes of 14 March 2024 (issued) were submitted and approved.

3. <u>Civic Licensing Standards Officer Update</u>

The Civic Licensing Standards Officer

- (1) outlined the failure statistics for Taxis and Private Hire Vehicles for the first quarter of 2024 (1 January to 31 March), compared to the same period in 2023 as follows:-
 - (a) 28% failure rate for the twenty nine Taxi Vehicles tested and eight vehicles which failed; compared to 19% in 2023 when thirty two Taxi Vehicles had been tested and six had failed; and

- (b) 9% failure rate for the forty six Private Hire Vehicles tested and four failures as opposed to 29% in 2022 when thirty eight vehicles had been tested and eleven had failed:
- (2) highlighted the various reasons for the vehicles failing the test;
- (3) advised that there had been an increase in Taxi Vehicles failing the inspection over this quarter compared with the first quarter of 2023, however, she was pleased to report that the percentage of Private Hire Vehicles failing the inspection had decreased for this quarter:
- (4) advised that all operators would continue to be monitored and, if necessary, brought before the Panel;
- (5) advised that today's training course was full and the next course would run on Thursday 6 June 2024; and
- (6) advised that the Licensing Team was extremely busy dealing with a significant number of applications for Public Entertainment Licences for events across the spring and summer, eg Ayr Agricultural Show, Carrick Lowland Gathering, Ballantrae festival of food and drink, Pavilion Festival, The Open Championships, several funfairs and many other events in South Ayrshire, with an application also expected for the Air Show later in the year.

The Panel, having expressed its disappointment at the increase in failure rates of Taxi Vehicles; and having outlined that applications for Public Entertainment Licences should be submitted with as much notice as possible in advance of the event,

<u>Decided</u>: to note the update from the Civic Licensing Standards Officer.

4. Civic Government (Scotland) Act 1982 - Licences

(a) Short Term Lets

Having heard from the Chair, the Panel

<u>Decided</u>: to note that the three Short Term Lets applications on the agenda would be considered at a later date.

Variation in Order of Business

In terms of Standing Order No. 13.3, the Panel agreed to vary the order of business as hereinafter minuted.

(b) Taxi Vehicle

The Panel heard from the Civic Licensing Standards Officer, the Fleet Officer and from the representative for the licence holder, Charles Cunningham in relation to the proposed suspension of his licence.

Decided: to take no action at this time.

(c) Private Hire Vehicle

(i) Having heard from the Chair, the Panel

<u>Decided</u>: to note that the application from Edward Holloway for exemption from displaying plates and door stickers on his vehicle, had been withdrawn.

(ii) The Panel heard from the Civic Licensing Standards Officer, the Fleet Officer and from the licence holder, William Gibson in relation to the proposed suspension of his licence.

Decided: to take no action at this time.

5. Exclusion of press and public.

The Panel resolved, in terms of Section 50A(4) of the Local Government (Scotland) Act 1973, that the press and public be excluded from the remaining items of business on this minute, on the grounds that they involved the likely disclosure of exempt information in terms of paragraph 6 of Part 1 of Schedule 7A of the Act.

6. <u>Civic Government (Scotland) Act 1982 - Licences</u>

(a) **Proposed Suspensions**

(i) The Panel heard from Police Scotland in relation to the proposed suspension of the licence currently held by Masood Sultanee.

Decided: in the absence of the licence holder, to suspend the licence currently held by Masood Sultanee with immediate effect in terms of Paragraph 11(2)(a) and (2)(c) of Schedule 1 of the Civic Government (Scotland) Act 1982 as, in their opinion, the licence holder is not, or is no longer, a fit and proper person to hold the licence and the carrying on of the licensed activity, is causing, or is likely to cause, a threat to public safety.

(ii) The Panel heard from Police Scotland in relation to the proposed suspension of the licence currently held by Nicholas James Krasewitz.

<u>Decided</u>: in the absence of the licence holder, to suspend the licence currently held by Nicholas James Krasewitz with immediate effect in terms of Paragraph 11(2)(a) and (2)(c) of Schedule 1 of the Civic Government (Scotland) Act 1982 as, in their opinion, the licence holder is not, or is no longer, a fit and proper person to hold the licence and the carrying on of the licensed activity, is causing, or is likely to cause, a threat to public safety.

(b) Taxi Drivers.

(i) The Panel heard from the Civic Licensing Standards Officer and from the licence holder, Abdul Rauf Hasan in relation to the proposed suspension of his licence.

Councillor Clark, seconded by Councillor Kilbride, moved that the Panel take no action at this time, however delegated powers be granted to the Service Lead -Legal and Licensing to suspend his licence for its unexpired duration should he not provide proof of completion of the training course on 6 June 2024.

By way of Amendment, Councillor Bell, seconded by Councillor Kilpatrick, moved that the licence be suspended with immediate effect on the grounds that the licence holder is not, or is no longer, a fit and proper person to hold the licence and the carrying on of the licensed activity, is causing, or is likely to cause, a threat to public safety.

On a vote being taken by electronic means, two Members voted for the Amendment and six voted for the Motion which was accordingly declared carried and the Panel

Decided:

to take no action at this time, however delegated powers be granted to the Service Lead - Legal and Licensing to suspend his licence for its unexpired duration should he not provide proof of completion of the training course on 6 June 2024.

(ii) The Panel heard from the Civic Licensing Standards Officer and from the licence holder, Iwan Kulakowski in relation to the proposed suspension of his licence.

Decided: to suspend the licence currently held by Iwan Kulakowski immediately for its unexpired duration as, in their opinion, the licence holder is not, or is no longer, a fit and proper person to hold the licence and the carrying on of the licensed activity, is causing, or is likely to cause undue public nuisance or a threat to public order or public safety

Report by Chief Governance Officer to Regulatory Panel (Licensing) of 23 May 2024

Subject: Taxi and Private Hire Vehicle age limits

1. Purpose

1.1 The purpose of this report is to seek an extension to the recent decision of the Regulatory Panel (Licensing) on 14th March 2024 to temporarily extend the upper age limit of taxis and private hire vehicles from 31st May 2024 to 11th October 2024.

2. Recommendation

2.1 It is recommended that the Panel:

- 2.1.1 grant an extension of the vehicle age limits to 11th October 2024 for the licence holders of taxi and private hire vehicles:
 - (a) currently holding an extension authorised by the Licensing service, following the Panel decision of 14th March 2024, subject to authorisation by Licensing including any required testing in terms of paragraph 2.1.3
 - (b) whose vehicles have reached or will reach their upper age limit in terms of Council policy between 14th March 2024 and 11th October 2024, who have advised Licensing of their intention to utilise the extension, and subject to authorisation by Licensing, including any required testing in terms of paragraph 2.1.3
- 2.1.2 if members agree to the temporary extension in terms of paragraph 2.1.1 above, request that the Co-ordinator (Licensing) advises the taxi and private hire trade of this temporary extension and requests that licence holders who (a)currently hold an extension and (b) whose taxi or private hire vehicles will reach the current age limit before 11th October 2024, contact Licensing if they wish to utilise this extension so the necessary arrangements can be made
- 2.1.3 if members agree to the temporary extension in terms of paragraph 2.1.1 above, grant delegated powers to the Service Lead Legal and Licensing to determine if any further vehicle testing is required in each circumstance.

3. Background

- 3.1 At the Regulatory Panel (Licensing) meeting on 14th March 2024, members were advised of a request from the Taxi and Private Hire Forum that an update of the Council Policy be considered, namely that (1) the age limit for first registering a vehicle as a taxi or private hire vehicle is increased from 4 years to 5 years; and (2) the age limit at which a taxi or private hire vehicle must cease to be used as such in South Ayrshire is increased.
 - Councillor Kilbride, as the Chair of the Forum, agreed that a Report should be prepared for Cabinet to consider this request for a change to the current policy.
- 3.2 Given the current challenging economic environment and difficulties experienced by licence holders Councillors Kilbride and Bell requested that a temporary extension to the upper vehicle age limits be considered by the Regulatory Panel (Licensing), to grant all vehicles which reach the current age limit before 31st May 2024 a temporary extension until the 31st May 2024 to allow them to continue to trade. This was agreed by Regulatory Panel (Licensing) on 14th March 2024.
- 3.3 The report which will be considered at Cabinet is currently being drafted with information being provided by various departments in the Council. It has not yet been finalised and will not be ready to be considered by Cabinet on 21st May 2024. It is now proposed that it will be heard at Cabinet on the 25th September 2024.

4. Proposals

- 4.1 It is proposed that the vehicle age limits are extended to 11th October 2024 for:
 - licence holders who currently hold an extension authorised by the Licensing service, following the Panel decision of 14th March 2024 subject to authorisation by Licensing including any required testing in terms of paragraph 4.2 below, and
 - licence holders whose vehicles have reached or will reach their upper age limit in terms of Council policy between 14th March 2024 and 11th October 2024, who have advised Licensing of their intention to utilise the extension, and subject to authorisation by Licensing, including any required testing in terms of paragraph 4.2 below.
- 4.2 It is also proposed that, due to the varying times when inspections and MOT's are due, to grant delegated authority to the Service Lead Legal and Licensing to determine if any further vehicle testing is required for any vehicle utilising the extension.

5. Legal and Procurement Implications

If the recommendations are rejected the taxi and private hire licence holders whose vehicles reach the upper age limit soon would not be able continue using their vehicle and may cease to use their licence or they may substitute another vehicle onto their licence at considerable cost when Cabinet may permanently extend the vehicle age limit in September 2024.

9.1 The proposals in this report have been assessed through the Equality Impact Assessment Scoping process. There are no significant potential positive or negative equality impacts of agreeing the recommendations and therefore an Equalities Impact Assessment is not required.
