### **AYRSHIRE CIVIL CONTINGENCIES**

# **AYRSHIRE CIVIL CONTINGENCIES TEAM**

4. There was submitted a report dated 31 October 2023 (circulated) by the Head of Legal and Regulatory Services, South Ayrshire Council, which advised the Joint Committee on proposals within the current Ayrshire Civil Contingencies Team (ACCT) Service Plan for 2024/2025, and noted work activity ongoing or achieved within 2023.

# PRESENTATION ON DIGITALISATION OF THE TEMPORARY TRAFFIC REGULATION ORDERS PROCESS

**5.** The Joint Committee received a presentation from the Business Support Manager, Ayrshire Roads Alliance, on the finalised digitalised process for Temporary Traffic Regulation Orders, due to go live on 4 December 2023.

The Joint Committee very much welcomed the new process, particularly in respect of those aspects relating to Local Member notifications, public access to information and links to social media, all of which would be greatly enhanced; and noted that the Business Support Manager would look at the potential to link notifications generated by the process directly to Members' mobile phone app.

# REVENUE FINANCIAL MONITORING REPORT

**6.** There was submitted a report (circulated) by the Chief Financial Officer and Head of Finance and ICT, East Ayrshire Council, which updated the Joint Committee on the revenue budget monitoring position as at 30 September 2023, for the Ayrshire Roads Alliance.

#### **RISK REPORT AND REGISTER**

**8.** There was submitted a report (circulated) by the Head of Roads: Ayrshire Roads Alliance, which advised the Joint Committee on the management of risk associated with the Ayrshire Roads Alliance.

On the matter having been raised by Councillor McMahon, the Head of Roads confirmed that it was intended that a report would be provided to early meetings of the Cabinets of both East and South Ayrshire Councils on a range of aspects relating to future EV charging point provision and operation within East and South Ayrshire Council areas, which would include considerations around provider and contractual arrangements and potential variations in same over the medium and longer terms, fair and consistent cost to users and resource implications including funding opportunities through the Scottish Government. In that regard, Members of the Joint Committee expressed support, in principle at least at this stage, to explore the potential for income generation for the two Councils, going forward.

# **ROADWORKS PROGRAMME 2023/24**

**9.** There was submitted a report (circulated) by the Head of Roads: Ayrshire Roads Alliance, which advised the Joint Committee on the progress of work through the roads improvement programmes within East Ayrshire and South Ayrshire for financial year 2023 to 2024.

Arising from the report, and in response to questions from Councillors Reid, Saxton and McMahon, respectively, the Head of Roads and the Strategic Manager: Roads (i) advised of progress with regard to the continuing roll out of the programme for the installation of LED streetlighing lanterns within Kilmarnock; and with re-instatement of the power connection to a particular lighting column at Woodlands Grove, Kilmarnock (scheduled for completion by mid-December), which information would be fed back to Local Members; (ii) confirmed arrangements for maintenance of fleet and public EV charging stations, and aspects around enforcement of overstay at EV charging stations; and (iii) confirmed that they would feedback directly to Councillor McMahon following the meeting with regard to timescales for removal of barriers at Castle Brae, Sorn.

# **AYRSHIRE ROADS ALLIANCE IMPROVEMENT ACTION PLAN**

In this connection, the Head of Roads also advised that it was intended that Road Asset Proposals for 2024/25 would be presented to East Ayrshire Council and South Ayrshire Council Cabinets in February; that, with effect from 3 January 2024, taxi licencing inspections for South Ayrshire Council would be undertaken by Ayrshire Roads Alliance at the fleet services depot at Crookedholm; and that a report would be presented to the Cabinets of both Councils shortly with regard to enforcement of bans on pavement parking as provided for within the Transport (Scotland) Act 2019, which will come into effect on 11 December 2023.
