Minutes of a hybrid webcast meeting held on 16 May 2024 at 10.00 a.m.

#### **Opening Remarks**

The Chair welcomed everyone to the meeting, outlined the procedures for conducting this meeting and advised that it would be broadcast live.

#### 1. <u>Declarations of Interest</u>

The Chair called the Sederunt for the meeting and having called the roll, Councillor Pollock advised that, it in terms of the Councillors' Code of Conduct, he would declare an interest in item 7(d)(2) below as he was a member of this Club. No further declarations of interest by Members of the Panel were made.

#### 2. Date of Next Board Meeting

The Chair advised that the next Board meeting would be held on Thursday 13 June 2024 at 10.00 a.m.

#### 3. Minutes of Previous Meeting

The Minutes of the Meeting of South Ayrshire Licensing Board of 18 April 2024 (issued) were submitted.

**Decided:** to approve the Minutes of the previous meeting.

#### 4. Update by Licensing Standards Officer (LSO)

The Licensing Standards Officer advised

(1) that there had been a number of events over the past few weeks in South Ayrshire that hade benefited from an Occasional Licence, including the Scottish Grand National Festival, the Ayr County Agricultural Show and the Pavilion Festival at Ayr Low Green; and that the Board approved some applications for extended hours for premises who hoped to take advantage of the anticipated increase in people in the area on these dates and had recognised them as of local or national importance;

- (2) that there had been no major licensing issues in relation to any of these events and in all cases the applicants had worked with the LSO and Police Scotland in advance and on the day;
- (3) that during these events, the local hospitality trade were expected to benefit from a significant additional number of people visiting the area and this week, accompanied by the Licensing Board Chair, she had met with some of the local premises managers and staff to discuss the impact these events had on business with it generally being reported that whilst everyone agreed it was very positive to have events in the area, in many cases they did not increase business and in some cases the associated road closures and diversions also discouraged regular customers on those dates. This seemed to depend on the type of event and target audience and, after further discussion it had been agreed that South Ayrshire had a wide variety of quality hospitality premises and any future event that was able to showcase these would be a positive and welcomed;
- (4) that with the recent sunny weather, many premises had been working hard to ensure that their outside drinking areas were ready for the summer and she reminded managers that any activities that were taking place in the outside drinking area must be contained in the operating plan and it was a local condition of premises licences in South Ayrshire that there should be no use of these areas beyond 10pm; and that, to include music, musicians, televisions or stages for example a non-minor variation application would first be required. She further reported that the Licensing Board Chair had recently visited some outdoor drinking areas to gain a better understanding of what was available; and
- (5) that many part-time and temporary staff had recently joined the licensed trade in South Ayrshire for what was hoped would be a busy summer season, that staff working in licensed premises required a minimum of two hours mandatory training and this must be documented and evidence of this available for inspection; and that in order to keep information consistent and to offer assistance, she would be providing a free staff training session at Maybole Town Hall on Thursday 6 June from 9.30am which was available for anyone who worked in licensed premises in South Ayrshire, however, spaces must be booked in advance.

The Chair outlined that he had been pleased to visit various premises and hear the experiences of members of the trade and their ideas for the future; advised of the importance of staff undertaking training; and encouraged all members of the trade to attend the training session in Maybole on 6 June 2024.







# Christopher Morrison – Number 47, Troon Occasional Licence Application – 18<sup>th</sup> to 21<sup>st</sup> July 2024 Report by Licensing Standards Officer

I refer to the Occasional Licence application made on behalf of Number 47 which is a premises who operate with later core hours in Troon. The application is to cover the use of a proposed outside drinking area during the period of the 152<sup>nd</sup> Open Golf Championships which are being held on the Royal Troon Golf Course in Troon and the dates requested are Thursday 18<sup>th</sup> to Sunday 21<sup>st</sup> July 2024 which are the main competition days.

Prior to lodging of this application, I was contacted by Christopher Morrison who is the Premises Licence Holder and Premises Manager of Number 47 and who had been attending the engagement events in the area which had been set up by representatives from the Golf Open and South Ayrshire Council. I advised Mr Morrison that he should contact Ayrshire Roads Alliance prior to further consideration of his proposal as the use of the 'space' proposed would involve 'adopting' parking bays and crossing a public footpath. Having seen an email exchange regarding this I can confirm that Ayrshire Roads Alliance have offered no initial objections to the proposal.

The application is to create an 'outdoor drinking area' using 4 parking bays which are situated outside Number 47 (see space labelled 3 on attached photograph) the purpose of which is to allow an external drinking space for patrons of Number 47 if the weather is favourable and to allow increased capacity for the venue, which currently stands at 120 persons inside. There are no proposals to offer food or entertainment within this area and there is no 'view' of the golf or any other entertainment from this location which is adjacent to a road, which I understand will be fully operational during this period. Additionally the applicant requests access for under 18's until 8pm and although no food will be served there is a variety of soft drinks on offer.

Whilst I am aware that Community Engagement groups have been encouraging local businesses to anticipate an increase in visitors in the area due to the Open Championships and consider ways to maximise business during this time, I would request that this application is not dealt with under delegated powers but is instead referred to a Board hearing for a decision.

As this proposal includes tables and chairs for people to sit in an area that is not usually for this purpose, it would be relevant to assume that there will be an increase in general noise in the locality as patrons drink, smoke, vape and socialise.

There are a number of flats opposite the premises and there have been complaints from residents who have been concerned about noise and anti-social behaviour in the past year from people who have left licensed premises. These have been referred to colleagues in the Communities team and I have contacted the previous complainants to make sure they are aware of the existence of this application as there is no process of automatic consultation for this type of application that would involve local residents. Although the applicant has indicated that the site will be covered by the CCTV positioned at the front of the premises and that he will be providing extra staff and door stewards, the Board may wish to consider if grant of the application would be consistent with the licensing objective 'Preventing Public Nuisance'.

The proposed location for the site is currently used as free parking spaces and are used on a daily basis by those visiting the commercial premises that are situated in Templehill. From personal experience I am aware that this is a busy area and I would anticipate the use of parking spaces to increase during this busy time in Troon. Whilst the applicant has advised that barriers will be in place to identify and secure the space, Members will be aware that the spaces at either side of the site will continue to be used by drivers who will be manoeuvring in and out to park and cannot be controlled by the applicant. The public road also borders the proposed area (see area labelled 4 on photograph) and I understand that the traffic management plan does not propose closure of this road and therefore it may be busier than usual if other roads in the area are restricted or closed. For this reason, the Board may wish to consider if the grant of this application is consistent with the licensing objective 'Securing Public Safety'.

There is a public footpath between Number 47 and the proposed outdoor space as shown in the attached photograph and labelled 2. This means that staff who are bringing alcohol from the premises to the drinking area and patrons who are moving from inside the premises to the outside space will have to cross the public footpath. In order to ensure this is not in breach of the Byelaw in South Ayrshire which prevents possession of 'an open container of alcohol in a public space' I assume a section of the footpath would require to be included in the Occasional Licence. The Depute Clerk will be able to advise on the legalities of this, however I would suggest that if granted, there is a condition added to the licence to prevent patrons from standing with or consuming alcohol on the footpath and it is instead simply used as a way to access the outside area. Although I have not personally had any communication with Ayrshire Roads Alliance I assume that it will be necessary to ensure the public footpath is not blocked and kept in use during this busy time to precent people from walking on the road or between parked cars.


This application is unique and no similar applications for Occasional Licences have been considered by South Ayrshire Licensing Board since the introduction of the Licensing (Scotland) Act 2005. However during the Covid pandemic the Scottish Government encouraged Licensing Boards to support premises who wanted to make use of outside areas and car parks in order to continue to trade. A few of these were granted for a temporary period in South Ayrshire but all used spaces that were owned by and attached to the premises and which were not accessed via a public footpath.

Christopher Morrison is an experienced operator who has owned and managed premises in the Troon area for many years and has contacted both Ayrshire Roads Alliance and the Licensing Standards Officer prior to lodging the Occasional Licence application. However the grant of this application would in my view set a president for future applications in South Ayrshire and therefore I would ask that if the Board were minded to grant this application, that they consider adding the following conditions to ensure compliance with the Licensing Objectives;

- 1- No glass is permitted in licensed area
- 2- A barrier must be used to define consumption area and a bin provided

- 3- All consumption of alcohol must be within the barrier area and not on the public footpath
- 4- A dedicated staff member must be present to supervise the area at all times

#### Alastair McClymont – Personal Licence Holder Occasional Licence Application – 27<sup>th</sup> July 2024 Report by Licensing Standards Officer

I refer to the Occasional Licence application made by Alastair McClymont for a 21<sup>st</sup> Birthday Celebration in a Marquee in the Front Field, Stafflar Farm, Symington.

The application requests a terminal hour of 1.00am, which is out with the Board's Policy. However, the location of the event is Stafflar Farm, a working dairy farm in Symington and the event is organised to take place in a marquee in the front field where neighbour noise and disturbance is unlikely to be an issue due to the rural location.

This venue has been used previously by the applicant, who was granted an Occasional Licence in 2022 for a 21<sup>st</sup> Birthday party for the same terminal hour and no negative feedback was received by Licensing as a result.

In the recent update to the Licensing Policy Statement, South Ayrshire Board added the following statement:

'The Board recognises that there are some venues which operate events such as weddings, on a regular basis with the benefit of Occasional Licences, and there are therefore applicants who appear before the Board throughout the year with applications for a terminal hour beyond 12 midnight. Where the applicant and venue are known to the Board and the application is for the type of event and hours that have previously been granted to the premises with no negative feedback from Police Scotland, the Licensing Standards Officer and the local community, the Board may grant the Clerk delegated powers for future similar applications. This decision would be taken at a Board meeting in relation to applications for a period of 12 months, subject to agreement with the consultees.'

Considering the above, I have no objections to the grant of this Occasional Licence and I would ask the Board to agree the delegated powers for the Clerk to allow any similar applications up until 31<sup>st</sup> December 2024 to be granted without the requirement of a Board meeting, if the required criteria is met.

As this is a community event and is being hosted within a rural village, the neighbours will be aware of this happening and many may be attending. For this reason, I have no concern that the grant of this application will breach the licensing objective 'Preventing Public Nuisance'.

As the applicant is known to me and has run a number of similar events over the years with the benefit of a 1am terminal hour, I have no objections to the grant of this application.

### REQUEST FOR RELAXTION OF LOCAL CONDITION RE:OUTDOOR AREA – MULLIGANS (RACHAEL RENNIE)

We would like to be considered for a request for the condition for the outside area to be relaxed for the Euros games. Many of the games are in the evening, and may run beyond the time permitted.

We are requesting that the 10pm is extended to 11pm for the purposes of drinking up time only (there will be no service of alcohol in the garden beyond 10pm) as some of the games are 8pm starts and this will allow customers to watch the end of the game should it run beyond 10pm.

The area will be effectively managed throughout this time (as it will always be) to ensure that we are meeting the licensing objectives.

We are requesting that this relaxation would apply for the dates of all of the games in the Euros tournament please.

As you can imagine, trying to clear the area if the game is still going on would be a huge challenge, and in the interests of promoting the Securing Public Safety objective, allowing these areas extra time would assist Licence holders to achieve this.

Aberdeen Licensing Board agreed a jurisdiction wide relaxation of licence conditions to allow premises with external areas to show Euro 24 matches and extend terminal hours of such areas where matches go into extra time.

The Pavilion Festival has been permitted time over the general 10pm terminal hour for outside areas for this reason, and so there is a precedent for areas within Couth Ayrshire to have hours beyond 10pm, so we would appreciate it being considered across other venues within the Board area.

Many thanks for your consideration and I am happy to discuss further if required.

#### M.E.T. Corporate Ltd - Mulligans, 7-9 Arthur Street, Ayr Request for relaxation of Local Condition Information from Licensing Standards Officer

The Premises Licence Holder for Mulligans has made a request to the Licensing Board to relax the local condition which restricts the use of the external drinking area to 10pm.

The reason for the request is so that the premises can show the football games from the Euro's from Friday 14<sup>th</sup> June to Sunday 14<sup>th</sup> July on the large screen in their outdoor drinking area and to be able to allow patrons to view the match until its conclusion outside if it goes on beyond 10pm.

This idea has been supported by some Licensing Boards in Scotland who have offered an area wide relation of the time restriction, however this would not be appropriate in South Ayrshire as these are the only premises who currently have permission to show football on an external screen with volume. Members will be aware that all activities that take place within an outdoor drinking area must be represented in the Operating Plan and as per the policy statement an acoustic consultant's report is required to accompany any application to include entertainment. As a result of the report provided for the outside area which now belongs to Mulligans, the Board granted permission for televised sport on a large screen television with the associated volume.

The layout of the outside drinking area and the television screen can be seen in the attached photographs.

Members should note that the neighbouring premises does NOT have permission to show sport with volume outside and the screen from Mulligans can be viewed and indeed heard from their outside drinking area which has a terminal our of 10pm as per the local condition.

There are a total of 51 matches over the period of one month as part of UEFA Euro 2024, however not all of these have an 8pm kick off and are therefore likely to go on later than the 10pm current curfew. If the Board were minded to allow the relaxation of the condition in respect of Mulligans, I would suggest that a list of dates is supplied by the premises and this can be shared with Police Scotland so that is clear on which nights the outdoor drinking area can be used until 11pm.

Being aware of other sporting events and other significant televised events, I would ask the Board to consider the reason for relaxing the condition on this occasion as this does not involve any consultation with neighbours or the local community who will be used to the 10pm curfew outdoors. The Board may also wish to consider their ability to withdraw the relaxation if a noise or disturbance issue arises during the month that would be inconsistent with the licensing objective 'Preventing Public Nuisance'.
