SAC established the Advancing Community Assets Fund to facilitate Community Asset Transfers by providing development and capital funding to qualifying community controlled bodies.

The Council provides direct support to community groups from initial enquiry through to submission of CAT request. Typically this support will comprise guidance and advice from the External Funding, Asset Management and Community Wealth Building Teams alongside the CAT Team Leader.

Presentations at a number of Community Council meetings during this reporting period to help promote CAT to the wider community. Creation of a new e-flyer and animation.

3.2 In particular what action has been taken to support disadvantaged communities to engage with the asset transfer process?

CAT Team Leader works closely with colleagues from SAC's Thriving Communities Service and external partners to raise awareness of the asset transfer process within our most disadvantaged communities. We work collaboratively to develop capacity within communities and support community-controlled bodies through every stage of the process.
