# **Matters Arising**

**Turning Area on Carrick Place** – Kevin Braidwood going to look into. It was agreed the area was not designed for the size of vehicles using it now and for the parking of cars.

**Kayaks** – GP confirmed that the transfer of the Kayaks to the DCR&WSC has been completed. TC advised the DCR&WSC are now looking into the insurance aspect and how to safely allow members of the community to use them. They will advise in due course.

**Bus Park Defib** – ME confirmed that the defib, provided by NCCBC is in the process of having the electrics completed and then will be fitted to the store in the park. GP has asked if NCCBC would take on the maintenance of the defib situated at the bus park, should they decline it has been decided that the DCC would cover the cost.

**Broadcasting of the DCC meetings** – MM has looked into whether there is a similar exercise elsewhere in Ayrshire. There is only two examples in Scotland that she has found of meetings being broadcast. At this time the committee will not take this forward.

**Loop System in Kennedy Hall** – The committee appreciate that this might be a benefit to a few members of the community, however, it is felt it would not be cost effective to fit at

this time whilst they are in the process of the Heritage Centre application. It could be re looked at in the future and MM going to advise on costs.

Heritage Sculpture – It is felt that it would be appropriate to have some sort of memorial for the fishing community from the village but this would be part of the Heritage Lottery Application and should not be rushed through. it would have to be discussed with the Harbour Committee as they would ultimately decide the siting of a memorial. IC going to mention to Mick Collier and ask that it be brought up at their next meeting. CM confirmed that he would attend the Harbour Committee AGM on behalf of the DCC.

**Scottish Fire & Rescue Public Consultation-** There is a consultation of Wednesday 19<sup>th</sup> June regarding the future of the fire services.

**Painting of the Kennedy Hall** – JM confirmed that this is on the agenda and looking to paint both the outside and the inside of the hall.

#### **Ongoing ARA Matters**

Kevin Braidwood advised that there was an issue with ARA installing directions to parking in the park as it is a private. GP questioned why we were not advised of this over a year ago as we have discussed this at every CC meeting. Provost Campbell asked Kevin Braidwood why he had been advised the signage had been made and was awaiting installation. Kevin Braidwood going to look into this further.

The 20mph scheme and the safety improvements are all out for consultation. ARA are applying for a temporary TRO (Traffic Regulation Order) which, if unchallenged, would allow the works to be carried out before the end of the summer.

Kevin Braidwood confirmed that the re-tarmacking of the road from the village to Dunure Mains southern junction is in next year's program of maintenance.

**Anchorage access** - No progress. GP confirmed that he has emailed Elena Whitham MSP and her office has reported back they will look into the matter.
