- 8. Matters Arising: None
- 9. Standing Items
  - iii. Car Parking/Town Regeneration
    - Problems being experienced with a works vehicle blocking footpath, Minnoch Crescent. Advised that this is police matter. No update at present
    - Meeting scheduled for 12<sup>th</sup> September, organised by Cllr Connolly
    - There seems to have been a loss of impetus and zero engagement at community level, areas we hope will be addressed with the appointment of an external company, something we have only recently discovered.
  - ii. Place planning:
    - Response to "How Good is our Place? Maybole" has been poor
      - Target is 10% return, currently less than 1%
    - Survey is important in that it informs the creation of community-led development plan
    - All members urged to complete survey and to encourage others to do so
  - iii. Housing/Community Care: No report
  - iv. Public Safety: no report
  - v. Locality planning
    - MA advised that a series of meetings have been planned up to Christmas
    - These will still be held on Thursdays at 2.00pm
    - Villages outside Maybole are included in the schedule
    - MF Informed he was meeting LPP to discuss position of Chair
  - vi. Planning:

- Query re the long-term security of houses built on sites which are historically boggy or subject to flooding, and implications for purchasers
- Cllrs advised that builder is responsible for land searches to ascertain that the land is suitable for house building
- Responsibility for flooding issues lies with ARA (Ayrshire Roads Alliance)
- SEPA also involved as statutory consultee
- Further query re "social obligation", concerning construction of a footbridge and park upgrade as part of the new housing development at the Glebe Councillor Connolly stated that Fiona Ross was following up on this unfulfilled requirement of planning
- vii. Licensing: nothing to report

## 10. New Business

- i. Remembrance Days
- ii. RBLS

Concern expressed that event had been held in June to mark 80 years since D Day, to which Maybole Community Council had not received an invitation to attend. Further, there was no publicity anywhere to alert the public to the event.

Action: - Write to RBLS to ask that when planning significant town events, Maybole CC are included in invitations to attend.

## 11. South Ayrshire Councillors

 Kincraig Court: road is in extremely poor state of repair but there is now a particularly dangerous hole at the edge of a drain cover on the side of the road where there is no pavement. This presents an immediate hazard to users and has been reported (confirmed by JP who checked website)

Cllr Grant confirmed that the road is on the list for resurfacing

- ii. Playpark Dailly Road: various problems have been reported which make the playpark unsuitable to young children to use. There is a proposal in place to move the playpark closer to the skatepark from under the trees and create a family friendly destination
- iii. Street names: Greenhead/Greenside mix up remains in place. Cllr Connolly advised that matter in hand
- iv. Greenside Notice Board:
  - Notice board is beyond repair
  - SAC have advised that is not a council responsibility
  - Cllr Connolly will follow up
- v. Fly Tipping/Cemetery tap
  - Concerns re materials dumped in Bryants Close which appear to include asbestos materials, road sweeping of area and removal of boundary fence with no replacement
  - Further concern re high pressure of tap at cemetery; need for pressure to be reduced so that tap can be used
  - Cllr Connolly will follow up on these issues
- vi. Damage to head stones and flowers in cemetery
  - Reports of damage due to grass cutting and strimming
  - This has been followed up and action taken to address
- vii. Summer Seat Kirkoswald Road
  - This is in poor state of repair and is overgrown
  - Cllr Connolly advised that this is now ARA responsibility and he will follow up.
    Potential to use ward money to replace the bench

Question raised whether or not weed killer is still applied given the proliferation of weeds across the town and rampant vegetation growth on footpaths such as at Red Brae.

Weed killer has been applied but the weather conditions this year has limited effectiveness

- viii. Town Hall Booking
  - Community groups are experiencing considerable difficulty when trying to make bookings on-line
  - The payment portal is particularly problematic
  - There appears to be a reluctance to grant evening lets
  - Reluctance to use at Hogmanay
  - This is a particular problem given that the Town Hall is now almost the sole area available for such events to be held
  - The notice board is also hard to access and the window has always been used for intimations. The hall is the heart of the town and community feel its uses are paramount for some of the community events.
  - Cllr Connolly advised that responsibility now lies with the Events Team at SAC and he has written to Fiona Campbell re the various issues that are proving a hinderance to the community
- ix. South Ayrshire Association of Community Councils
  - MF advised that this group has appeared recently and has stated that all community councils are involved but there has been no commitment from Maybole and exception was taken to the statement in the press where they say all community councils struggle with communication to and from the council. Maybole CC has made no such commitment or statement. MF recommended we do not get involved at this time and will follow up with them to that effect.
