Budget Survey 2025-26

1. Background

1.1 The Council conducted a budget survey during December 2024 and January 2025 (closing date 31 Jan) to gather public input on financial priorities, service charges, and potential cost-saving measures. A total of 703 responses were received. Appendix 1 provides a note of the questions asked within the survey. Two questions allowed free text and suggestions to be made (questions 6 and 9). The thematic analysis of the responses identified key areas of concern and recommendations from residents which is provided in section 2 below.

2. Considerations

2.1 **Potential Service Charges**

- Environmental and Waste Management Services: Many respondents suggested introducing or increasing charges for services such as grass cutting, additional bin collections, recycling centre visits, and special uplifts for large waste items.
- Leisure, Tourism, and Cultural Services: There were recommendations to introduce or increase charges for golf courses, sports facilities, museums, and tourism-related fees, including parking at tourist sites and entry fees for major events like the Ayr Show.
- **Social and Welfare Services**: Suggestions included means-testing free school meals and transport, introducing charges for certain care services, and limiting free bus passes to those in financial need.
- **Business and Economic Contributions**: Respondents advocated for higher business rates for landlords and short-term rentals, fees for council-supported training, and penalties for neglected properties.

2.2 Survey Results

- Preference on Fees vs. Service Reduction:
 - 16.9% of respondents preferred an increase in fees and charges rather than reductions in services.
 - 41.8% favoured reductions in service provision over increased charges.
 - 41.3% favoured a combination of both.
- **Council Tax Considerations**: The survey highlighted that council tax contributes 20% of income for public services.
 - 22% of respondents were willing to accept a higher-than-normal increase to maintain services, while 71% opposed it. 7% were not sure.
- **Above-Inflation Fee Increases**: Residents indicated a willingness to pay increased fees for:
 - Leisure activities such as swimming and golf (38% in favour).

- Neighbourhood services like special uplifts and bereavement services (20% in favour).
- Parking charges (29% in favour).
- School meals (14% in favour).
- New Charges Introduction:
 - 56% of respondents supported introducing new charges, such as a visitor levy, to help prevent service cuts.
 - 44% opposed new charges.
- **Service Reductions**: Respondents were asked which services, if any, they would be willing to see reduced:
 - 22% said Enabling Services.
 - 19% said Planning and Development.
 - 18% said Economy and Regeneration.
 - 16% said thriving communities.
 - 13% said Destination South Ayrshire
 - 4% said Neighbourhood services.
 - o 3% said Education.
 - 2% said Other.
 - o 2% said HSCP.
 - 1% said Roads.
- Digital Services vs. Face-to-Face Interaction:
 - 67% of respondents indicated they would be willing to use more online services to reduce costs associated with in-person customer interactions at Council buildings.
 - o 33% preferred maintaining face-to-face services despite higher costs.

2.3 Cost-Saving Measures

- **Reducing Management and Bureaucracy**: There is a strong call to reduce the number of senior and middle management positions, eliminate redundant roles, and conduct salary reviews.
- **Better Utilisation of Council Assets**: Respondents suggest selling or leasing unused buildings, increasing charges for council facilities, and seeking commercial partnerships to generate revenue.
- **Cutting Non-Essential Spending**: Many believe funds should not be allocated to "vanity projects" like public sculptures or underused redevelopments.
- Enhancing Efficiency in Service Delivery: Proposals include merging administrative functions with neighbouring councils, digital transformation to cut costs, and stricter enforcement of fines and fees.

• **Encouraging Community Engagement**: Suggestions include volunteer programs for park maintenance, increasing business responsibility for litter control, and enhancing public involvement in budget decisions.
