Chair's Remarks

The Chair

- (1) welcomed everyone to the meeting; and
- (2) outlined the procedures for conducting this meeting and advised that this meeting would be broadcast live.

1. Sederunt and Declarations of Interest.

The Co-ordinator (Licensing) called the Sederunt for the meeting and having called the roll, Councillor Cavana declared an interest in item 6(a)(i) of this Minute as the applicant's family was known to him, in terms of Council Standing Order No. 17 and the Councillors' Code of Conduct.

As Councillors Kilpatrick and Townson left during the previous meeting, they were unable to vote on the previous Minutes. As Councillors Cavana and Lamont had declared an interest in an item on the agenda they were also unable to vote.

2. Minutes of Previous Meeting

The minutes of 23 January 2025 (issued) were submitted and approved.

Councillors Kilpatrick and Townson left the previous meeting prior to consideration of the following application and Councillors Clark and Mackay were not in attendance at the site visit, therefore, they could not take part in consideration of this application and left the meeting at this point.

3. <u>Civic Government (Scotland) Act 1982 - Licences</u>

(a) Short Term Lets

Orchard Flat, 2D Racecourse View, Ayr

Reference was made to the Meeting of 23 January 2025 when it had been decided to undertake an accompanied site visit to the premises; and to the site visit of 14 February 2025; and the Panel now heard from the applicant's representative and from the representative for the objectors and adjourned for consideration of this application.

Upon reconvening, the Panel

<u>Decided</u>: to approve this application for one year, subject to standard conditions as previously agreed

Councillor Kilbride left the meeting at this point.

Councillors Clark, Mackay and Townson re-joined the meeting at this point. Councillor Kilpatrick did not re-join the meeting,

4. Short Term Lets

The Service Lead – Housing Strategy and Regeneration provided the Panel with an update on the Short Term Lets Scheme and the work undertaken by him and his Team.

The Panel, having thanked the Service Lead and his staff for their work on this matter,

<u>Decided</u>: to note the update.

5. Exclusion of press and public.

6. Civic Government (Scotland) Act 1982 - Licences

(a) Taxi Driver Licence

(i) The Panel heard from Police Scotland and from the representative for the licence holder, Mark Ballantyne in relation to the proposed suspension of the licence currently held by him, under Paragraph 11 of Schedule 1 of the Civic Government (Scotland) Act 1982, and adjourned for consideration of this matter.

Upon reconvening, the Panel

<u>Decided</u>: not to suspend the licence, and to take no further action in relation to this matter.

Councillor Cavana re-joined the meeting at this point.

(ii) The Panel heard from Police Scotland in relation to the application from Gemma Hosie.

The Panel

<u>Decided</u>: to refuse this application in terms of Paragraph 5(1) of Schedule 1 of the Civic Government (Scotland) Act 1982 as, in their opinion, the applicant is not a fit and proper person to be granted a licence.

(iii) The Panel heard from Police Scotland and from the applicant, Ross Jarvie, in relation to his application.

The Panel

<u>Decided</u>: to approve this application subject to standard conditions as previously agreed.

(iv) The Panel heard from the Co-ordinator (Licensing) and from the applicant, Richard Colville in relation to his application.

The Panel

<u>Decided</u>: to approve this application, subject to standard conditions as previously agreed.

Councillor Mackay left the meeting at this point.

(b) **Training**

The Panel considered the proposed suspension of various licences as the licence holders had not completed the mandatory training.
