### INTRODUCTION



South Ayrshire Council's plan for education reflects the important recovery, and improvement period 2021-2024. The plan takes account of our evaluation work in taking forward School as Learning Organisation and links to the National Improvement Framework and drivers.

Our vision and ambition remains to achieve excellence and equity and support each learner to achieve their potential. Over the course of the next school session we will revisit our vision to ensure it reflects our focus on high quality learning and teaching, and our ambitions for all

At the start of the school session we will gather additional information to support staff in targeting resources to mitigate the impact of loss of learning and inequalities that exist for groups of children and young people.

This service plan builds on the very strong teamwork demonstrated by staff across the service both in schools and in the central team. It highlights our collective commitment to ongoing improvement and getting the best outcomes for all learners.

Develop and implement improved and consistent approaches to monitoring and tracking progress in the BGE

Implement standardised assessments at key stages as part of the recovery approach to support staff in identifying gaps in the children's learning

Continue to improve teacher professional judgement through assessment and moderation activities

Continue to implement the 4 stages of progress model within the BGE

Continue to evaluate and review the way we report children's progress

Develop high quality outdoor learning opportunities in collaboration with partners across the local authority

Develop a parental involvement and engagement strategy involving parents, partners and the wider school community

Undertake a review of the unified senior phase model to ensure that it is meeting the needs of young people

## Closing the attainment gap between the most and least disadvantaged children

#### What do we want to achieve?

Improve attendance of all children and young people including those who are care experienced and those residing in the lowest 20% Scottish Index of Multiple Deprivation (SIMD)

Reduce exclusions (rate per 1000) of children and young people in the lowest 20% SIMD and care experienced children and young people

Improve tracking and monitoring of targeted groups (including those children and young people in Quintile 1, care experienced and young carers)

Improve the percentage of children and young people in the lowest 20% SIMD and those care experienced achieving expected Curriculum for Excellence (CfE) levels

Improve the average complementary tariff points of young people (leavers) in the lowest 20% SIMD and looked after young people

Improve the percentage of leavers in the lowest 20% SIMD achieving levels 4 and 5 in literacy and numeracy

Increase the percentage of young people in the lowest 20% SIMD and looked after young people who stay on at school (S4 staying on to S5)

Implement robust and consistent tracking and monitoring of targeted groups (including those children and young people in Quintile 1, care experienced and young carers) through the development of tracking systems

Implement refreshed national Child Protection guidance

Implement refreshed national GIRFEC practice model guidance

Implement the Scottish Attainment Challenge and Pupil Equity Funding revised models to support closing the poverty related attainment and opportunity gap

Continue to develop school and authority-based nurture programmes and provision to provide enhanced health and wellbeing support to children and young people

Develop the new Autism Outreach service to promote and support the inclusion of learners in mainstream settings

Rigorous monitoring and promotion of improved attendance particularly for targeted groups

Deliver training and ongoing coaching in context on the Compassionate and Connected Community

Pilot a new assessment, intervention and evaluation process with the Autism Spectrum Disorder outreach team

Promote the use of and development research to increase the use of evidence-based practice to improve learning and teaching, and outcomes
