

## Standard Conditions on a Market Operators Licence

1. The Licenceholder is permitted to operate a private market at \_\_\_\_\_ and in no other premises.
2. The use of the premises is restricted to that of a market selling \_\_\_\_\_
3. The Licenceholder is permitted to trade during the hours of \_\_\_\_\_
4. The Licenceholder is permitted to locate a maximum of \_\_\_\_\_ stalls in the licensed premises.
5. The Licenceholder shall ensure that the premises conform to the requirements of the Health and Safety at Work, etc Act 1974 and any Regulations or Orders arising therefrom or amendments thereto.
6. The Licenceholder shall ensure that the premises are generally in compliance with the Food Safety Act 1990 and all Regulations, Orders etc., relating thereto.
7. The Licenceholder shall make suitable arrangements for the collection and disposal of all refuse to the satisfaction of the Head of Environmental Health Services.
8. The Licenceholder shall ensure, by agreement with adjoining property owners, that the doors at the end of the passageway forming the fire exit route from the side and rear of the market remain unlocked and available for use a fire exit at all times when the market is open to the public.
9. The Licenceholder shall ensure that in the case of a stall or unit having for sale such items as crossbows or air weapons in respect of which the sale to persons under 17 years of age is prohibited by law, the Licenceholder will take reasonable steps to ensure that at all times when the market is open to the public (a) the stall or unit is attended by the occupier thereof or by a responsible person appointed by the occupier; and (b) all such items and any other items within the stall or unit which can reasonably be regarded as potentially dangerous weapons, are either effectively secured or kept out of the reach of members of the public.
10. The Licenceholder shall ensure that a register with individually numbered pages and entries showing the date each time a market is held, the name, address, telephone number, and normal place of business of each stallholder or retailer, the nature of the goods sold and the vehicle registration mark of any vehicles used or to be used in connection with the said market.
11. The Licenceholder shall ensure that each stall allocated to registered stallholders shall have a separate number which shall be recorded in the register along with the stallholder's details.
12. The Licenceholder shall ensure that the register must be available for inspection by an authorised officer of the Council or the fire authority or a Police Constable when the market is open for business and must be retained by the licensee for a period of two years.
13. The Licenceholder shall ensure that stallholders report their presence and provide the necessary details as required in the register to the agent responsible for the day-to-day operation of the market prior to the stallholder commencing to trade.
14. The Licenceholder to ensure that no stallholder present at the market is trading without the permission of the Licenceholder.
15. The Licenceholder shall ensure that at time of registration at the market each stallholder will be issued with a registration badge clearly and legibly bearing the following information:

The name of the market

The statement "official market trader"

The number of that trader's stall

16. The Licenceholder shall ensure that each stallholder is informed that this registration badge should be worn prominently by themselves or by some other person working at their stall.
17. The Licenceholder shall ensure that stallholders comply with this instruction.

**Note:-**

“The Licenceholder is advised that any person trading in Second Hand goods from a stall within the market will, subject to the provisions of Section 24(3) of the Civic Government (Scotland) Act, 1982, require the benefit of a Second Hand Dealer Licence. The Licenceholder is obliged to draw this to the attention of all stall holders/tenants as appropriate.”
