# **NORTH CARRICK COMMUNITY BENEFIT COMPANY (NCCBC)**

North Carrick Community Benefit is a community-based company (No: SC480121) with charitable recognition (No: SC045947). It has been distributing funds from Scottish Power Renewables' Dersalloch windfarm since 2015. The company focuses on the roughly 9,500 people living in the 5 community council areas in North Carrick: Crosshill, Straiton and Kirkmichael as 1, Kirkoswald, Maidens and Turnberry as 1, and then Dunure and Minishant and Maybole as the other 3 areas.

NCCBC is a membership organisation with membership open to anyone who lives in the area. It has around £300,000 available to spend on improvements in North Carrick each year.

Applications can be submitted by any constituted group that delivers benefits for people in North Carrick. Applications will be considered where they deliver new and innovative projects which promote one or more of the following priorities:

- Regeneration of our built environment for general public benefit
- Environmental Protection and improvement
- Provision, maintenance, or improvement of Public Open Space
- Projects which reduce Greenhouse Gas emissions
- Projects which promote more efficient use of scarce global resources
- Education for local residents
- Recreational activities/facilities
- Protection, preservation, or enhancement of important or significant local buildings
- Alleviating poverty





- Providing training or employment opportunities for unemployed individuals or groups
- Health benefits
- Alleviating hardship caused through health, disability, isolation or other disadvantage
- Citizenship, capacity building, engagement, volunteering and support for individuals and communities
- Arts, Heritage, or culture

### **CARRICK FUTURES**

Carrick Futures supports community projects in Carrick, South Ayrshire.

The fund supports projects primarily located within or directly benefiting one or more of the six community council areas of Ballantrae, Colmonell & Lendalfoot, Barr, Barrhill, Pinmore & Pinwherry and Girvan & District.

Some funds are also available for projects located within or directly benefiting the wider Carrick area. Priority will be given to applications which also benefit one or more of the main beneficiary communities listed above.

# What Can Carrick Futures Fund?

Carrick Futures can support charitable activities that support the rural regeneration and sustainability of Ballantrae, Colmonell & Lendalfoot, Barr, Barrhill, Pinmore & Pinwherry, Girvan & District and Carrick.

Awards can support a wide range of costs and activities.

The Board has agreed four strategic aims, which it will use to prioritise proposed projects. These are:

- Improving access to services (in particular public transport)
- Enabling a diverse and sustainable population mix (services for young people and older people, but also activities that help create opportunities for families and working age people to live in the area).
- Improving equality of opportunity (including tackling poverty and disadvantage).
- Contributing to a climate smarter world with sustainability at its core

Applicants must normally fulfil the following conditions to apply to the fund:

• The proposal is for projects or activities consistent with the charitable purposes of Carrick Futures;





- Applicants have a constitution (governing document or set of rules) and are set up on a notfor-private-profit basis. However applicants do not need to be registered charities to apply.
- Applicants must provide their latest set of accounts, signed by an independent third party, and a copy of a recent bank statement.

# **Gillian Stevenson Charitable Trust CIO**

Funding body:	Gillian Stevenson Charitable Trust CIO
Maximum value:	£ 5,000

Grants are available for UK registered charities working with children, young people and families in the UK who are living in difficult circumstances or are from disadvantaged backgrounds.

### Further details

### **Background**

The Gillian Stevenson Charitable Trust, a registered charity set up in 2021, is a family CIO who aims to help charitable organisations in the UK 'carry on making a difference to the people that they work with'.

### Objectives of Fund

The Trust offers responsive funding to charitable organisations working with young people and families in the UK who are in need due to ill health, disability, financial hardship or some other disadvantage.

There is particular interest in supporting organisations which provide access to activities, experiences, services or facilities that their beneficiaries would otherwise find difficult or impossible to take advantage of.

### **Value Notes**

Grants of between £100 and £5,000 are available.

### **Match Funding Restrictions**

Match funding is not required as the Trust will consider funding up to 100% of the project costs.





### Who Can Apply

To be eligible, applicants must either:

- Be registered as a charity with the Charity Commission for England and Wales, the Office of the Scottish Charity Regulator and/or the Charity Commission for Northern Ireland (from grant-making policy), or
- Qualify as a charity under the law of England and Wales, but not required to register with the Charity Commission for England and Wales.

Applications will be accepted from the following types of organisations:

- Informal group/community group
- Registered charity
- Charitable company limited by guarantee
- Charitable Incorporated Organisation (CIO)
- Community Benefit Society

To be eligible, applicants must be able to provide the following documents with their completed application form:

- Governing document/constitution
- Most recent audited or authorised statement of accounts
- Most recent bank statement
- Safeguarding Policy if their work involves children and young people or vulnerable adults.

#### Restrictions

The following are not eligible for funding:

- · Salary costs.
- Capital costs unless directly related to the funded project, service or activity and it can be demonstrated how the items will be used after the funding period ends.
- Organisations that have previously submitted a proposal where the applicant failed the Charity Trustees' due diligence checks and the issues identified at that time have not been addressed.
- Any organisation that has been awarded a grant by The Gillian Stevenson Charitable CIO in the previous 12 months.

# Eligible Expenditure

The funding can be used for the following:

- A one-off purchase of equipment.
- A new or one-off project, service or activity.
- The continuation of a project, service or activity that already being provided.
- Emergency funding to cover running costs of the organisation so that it can continue to function. (Note the funding cannot cover routine running costs).

# **How To Apply**

Applications can be made at any time throughout the year and are considered at quarterly meetings.

The next deadline for applications is 28 February 2023 to be considered at a grants panel meeting on 24 March 2023. Applications that miss the deadline will be considered at the next meeting, which is likely to be in June 2023.

Loans and equity finance to support the growth of small and medium-sized businesses in Scotland.

### **Background**

This Fund is provided by the British Business Bank. The British Business Bank is responsible for administering the Nations and Regions Investment Funds on behalf of the UK Government. The Bank is establishing investment funds in areas not currently served by the Bank's existing regional funding programme before launching follow-on investment funds in existing fund areas.

# **Objectives of Fund**

The British Business Bank is set to launch a £150 million investment fund in summer 2023, aimed at driving the growth of small and medium-sized businesses in Scotland.





The Investment Fund for Scotland is one of a series of Nations and Regions Investment Funds being launched by the British Business Bank which will deliver a £1.6 billion commitment of new funding to smaller businesses across the UK.

The scheme will have a demonstrable presence across Scotland, linking up with the existing small business finance ecosystem to increase reach and create an impact by helping to boost productivity, innovation and jobs.

By increasing the supply and diversity of early-stage finance for smaller businesses in Scotland, it aims to tackle an identified funding gap. Similar funds are planned for Wales, Northern Ireland and the South West of England, along with follow-on funds for the Midlands and the North of England.

#### Value Notes

The £150 million for will offer a range of commercial finance options, with small loans from £25,000 and equity investment up to £5 million.

The Fund will operate across three tiers: smaller loans (£25,000-£100,000), debt (£100,000-£2 million) and equity (up to £5 million).

Small and medium-sized businesses in Scotland may apply.

The British Business Bank is currently inviting proposals from potential fund managers to operate the new Investment Fund for Scotland via its website. It expects to appoint fund managers in spring 2023 ahead of launching in the summer.

# **Background**

Randall Charitable Foundation provides grant funding to a wide range of charities, voluntary groups, and non-governmental organisations to achieve the following aims:

- Directly saving lives.
- Improvements to primary healthcare, globally, and to aid the distribution of quality medicines to lower and middle-income countries.
- Helping people living with severe mental health issues.
- Relief of sickness, protection of good health, and the raising of life expectancy.
- Prevention or relief of poverty and improving the quality of life of the most vulnerable.
- Social disadvantage because of age or disability.
- Enabling children facing extreme hardship or social disadvantage to access education.

# **Objectives of Fund**

This fund aims to support work connected to health, mental health, addiction, poverty, education, and social disadvantage.

#### Value Notes

Both small scale-grants (under £3,000) and larger-scale grants are available.

The Foundation supports one-off causes as well as projects that span over multiple years.

General funding may be provided for charities on a specific case-by-case basis.

# Who Can Apply

Applicants must provide:

- A copy of their latest trustee's report.
- Safeguarding policy.
- Financial statements.
- A full budget.

Funding is for projects and activities that benefit the following:

- Children, young and elderly people.
- Individuals living with a disability.
- Individuals requiring healthcare assistance.
- People living with severe mental health issues.
- Those living in poverty and financial hardship.
- The socially disadvantaged.
- Those suffering from addiction.





- Other charities/voluntary organisations.
- General public.

### Eligible Expenditure

Funding is available for projects and activities that fall under the following categories:

- Health such as:
  - Delivering food and medicines.
  - o Home care for elderly patients leaving the hospital.
  - Support for people with critical illnesses, people with disabilities, and people suffering from loneliness.
- Mental health such as:
  - Support for young people and families who are disadvantaged through no fault of their own, such as victims of domestic violence and sex trafficking.
    - Suicide prevention.
- The prevention and relief of poverty
- Social disadvantage such as:
  - Helping older people who are isolated or have mobility issues.
  - Post-hospital care.
  - Educational support services for young people.
- Addiction such as:
  - Work that focuses on tackling the root causes of addiction.
  - Helping addicts to recover.
    - Recovery support for families affected by drug use and addiction.
- Education such as:
  - Work that helps young people recognise their worth and full potential, so they are equipped to build the skills and vision for their future success and employment.

Applications can be made at any time.

# **Foundation Scotland - Ballantrae Education and Training Fund**

Grants are available to residents of Ballantrae, South Ayrshire, to support access to training and education opportunities.

# **Background**

The Ballantrae Education and Training Fund is provided from the Ballantrae Community Fund (from the Scottish Power Renewables Glen App Windfarm in South Ayrshire). The Fund is administered by Foundation Scotland.

Support is available to residents in Ballantrae, South Ayrshire, to access training/education opportunities to enter or retain employment.

# **Objectives of Fund**

The aim of the Fund is to support residents of Ballantrae in South Ayrshire to retain employment or to access training and education opportunities. This will improve opportunities and livelihoods of those living in the area.

### **Value Notes**

Maximum awards are:

- First time applicants: up to £1,000
- Second time applicants: up to £750
- Any further applications: up to £500 per year.

If the course runs over several years, any award will be capped at:

- First year of study or short courses: up to £1,000
- Second year of study: up to £750
- Any further year of study: up to £500 per year.

### **Match Funding Restrictions**

Match funding is not a specified requirement.





### Who Can Apply

Residents of Ballantrae aged 18 years or older are eligible to apply but priority will be given to those aged between 18 and 25 years old.

Any course undertaken locally (i.e. south and central Scotland) will be looked upon more favourably than a course requiring the applicant to leave the area.

Apprentices can apply for costs that cannot be claimed back from their employer or any other source.

Courses leading to formal or recognised qualifications will be favoured. However, other courses will also be considered where the applicant can demonstrate how the skills and knowledge gained will realistically support them in securing a job, retaining a job or in setting up their own business.

#### Restrictions

Funding is not available for the following:

- Retrospective funding.
- Training or equipment that the employer should provide.
- Support for residents outwith of the Ballantrae Community Council area.

### Eligible Expenditure

Awards may cover costs directly related to attending the course/apprenticeship, including:

- Course fees (if the costs cannot be waived or funded through another source).
- Study aids and equipment e.g. laptops, software, stationery.
- Technical aids/equipment e.g. specialist clothing relating to the course, tools, other specialist equipment.
- Travel e.g. bus, train, petrol.
- Accommodation costs.

Both full and part-time courses are supported.

## Location

Ballantrae, South Ayrshire

### How To Apply

Applications are accepted any time.

Applications can be submitted online at the Foundation Scotland website and supporting documentation should be included, such as:

- The offer letter or confirmation of a place on the course.
- A copy of the attendance record or statement by someone from the educational institution confirming the applicant has been attending regularly.





- A copy of the qualification certificate.
- A bank statement may be requested that shows the applicant's name, address, account number and sort code.

Applicants will be advised of the funding decision approximately six to eight weeks after submission.

Grants are available to charitable organisations for community projects in Pinwherry and Pinmore, South Ayrshire.

### **Background**

The Pinwherry and Pinmore Community Fund was established by the Pinwherry and Pinmore Community Council and is funded by SSE community benefit funding (from the Hadyard Hill wind farm) and Falck Renewables (from the Assel Valley wind farm). The scheme is administered by Foundation Scotland.

The Fund supports the local community area of Pinwherry and Pinmore.

# **Objectives of Fund**

The aim of the Fund is to support community projects to benefit residents in the Pinwherry and Pinmore areas.

### Value Notes

There are two funding streams available:

• Standard Grant: £500 to £10,000

• Large Grant: over £10,000 to £25,000

Eligible organisations may apply for more than one grant per year and can be multi-year (but for no longer than three years).

# **Match Funding Restrictions**

Match funding is not a specified requirement.





### Who Can Apply

Charitable, community-led organisations working to benefit the residents of Pinwherry and Pinmore are eligible to apply. Groups do not have to be a registered charity to apply.

To be eligible, organisations must:

- Be constituted and have charitable purposes described in the governing document.
- Have a bank or building society account with at least two unrelated signatories.
- Have a minimum of three unrelated persons on the management committee or board.
- Have the latest set of accounts inspected and signed by an independent party.
- Have safeguarding policy and procedures, if applicable.

Applications from organisations located outwith the fund area will be considered on a case-by-case basis and must demonstrate a clear benefit for residents within the area.

#### Restrictions

Funding is not available for the following:

- Non-constituted groups.
- Applications from individuals.
- General fundraising appeals or activities.
- · Trips abroad.
- Retrospective funding.
- The repayment of loans or payment of debts.
- The advancement of religion or politics, including requests to support religious or political groups' core activities.
- Payments towards areas understood to be the exclusive responsibility of statutory authorities.
- Activities that are likely to bring the fund, Foundation Scotland or the donor into disrepute.
- Activities that conflict with the interests of the funder.
- Projects which do not benefit the people of the designated local area.

### Eligible Expenditure

A range of costs and activities including equipment costs, running costs for local groups, staff or sessional worker costs, consultations, maintenance or refurbishment of community facilities are available through the fund.

### **How To Apply**

The closing date for applications is 7 April 2023 for decisions in June 2023.





Applications for Standard Grants should be submitted online at the Foundation Scotland website before the closing date. For Large Grants, an online enquiry form must be completed and successful applicants will be invited to submit a full application.

The Pinwherry and Pinmore Community Fund Advisory Panel reviews applications and advises on fund strategy.

# **Resilient Theatres: Resilient Communities Grant Programme**

Capacity building grants are available to support the restoration, reopening or revitalising of community theatres on the Theatres Trust's Theatres at Risk Register.

# Background

The Resilient Theatres: Resilient Communities Grant Programme has been launched by the Theatres Trust to support theatres at risk. It is supported by the National Lottery Heritage Fund, the Swire Charitable Trust and the Pilgrim Trust.

### Objectives of Fund

The scheme aims to enrich the knowledge, skills and confidence of the cultural heritage sector, but specifically communities considering or already taking over a theatre building, thereby reducing the threat to at-risk theatres and leading to greater sector resilience.

This grants programme is for theatres on the trust's Theatres at Risk Register, and the community and campaign groups that support them. Grants are to help groups to acquire the skills and knowledge needed to restore and reopen these theatres. The fund will not support the capital works themselves.





### Value Notes

Grants of between £5,000 and £20,000 are available (although it is likely the majority of grant awards will be up to £10,000).

# **Match Funding Restrictions**

Match funding is not required; however, should a project cost exceed the Resilient Theatres: Resilient Communities grant proof of partnership funding will be required.

# Who Can Apply

To be eligible, Organisations must have UK charitable or not-for-profit legal structure to apply. Local authorities are also eligible.

It is not necessary for recipients to own or lease the theatre building; however it is necessary to have a specific ambition for the removal of the building from the Theatres at Risk Register through the restoration/reopening of the venue. Permission from the owner to undertake the project is also required, where necessary.

### Restrictions

Capital works are not eligible.

### Eligible Expenditure

The type of support that might be funded includes:

- Viability studies and options appraisals.
- Building condition surveys and structural reports.
- Business planning and fundraising strategies.
- · Economic impact studies.
- · Governance reviews.
- Heritage statements.
- Audience development plans.
- Archival research or collecting people's memories (oral history collection) or ephemera related to the theatre.

Projects will be prioritised according to:

- The urgency of the project.
- Being 'at risk' (ie on the Theatres at Risk Register) and the extent to which the grant will make a significant difference to promoting the better protection of the theatre those that are considered to have the most impact in realising a fundamental step towards removal of the theatre from the Theatres at Risk Register will be prioritised.
- Being of heritage value, including whether the building is formally listed or locally listed.
- Being in an area of economic deprivation.
- Of community value demonstrating there is significant local support for the building.
- In danger of becoming at risk.

# Background

The Future Takes programme is provided by BFI in partnership with Film4.

### Objectives of Fund

The funding is intended to support creative teams to make films that can gain major recognition and open up new opportunities for the filmmakers involved, serving as a realistic stepping stone towards a first feature or long form commission.

# Value Notes

The programme will fund approximately seven projects, with grants of between £35,000 and £90,000 available.

### Who Can Apply

Applications will be accepted from teams of writers, directors and producers based in the UK to support the production of higher-budget live action, short form film work.





### Restrictions

The following are not eligible for funding:

- Core costs for day-to-day running of a production company not associated with the film project.
- Activity that is already specifically supported by another external source of funding.
- Costs incurred prior to an offer of funding from BFI.

### Eligible Expenditure

The programme supports the production of scripted live action work or hybrid documentary involving scripted or dramatised elements.

The funding is intended to cover all costs incurred to deliver a finished film with an intended length of a maximum 25 minutes.

# **Background**

Civic Power Fund is the first donor fund dedicated to community organising in the UK.

### Objectives of Fund

Funding is intended to support community organisers who are tackling injustice and inclusion.





### **Value Notes**

Grants of £2,500 to £20,000 are available.

# Who Can Apply

The fund is open to not-for-profit organisations with a turnover of less than £250,000 that are:

- Rooted in and accountable to their community.
- Hoping to achieve long-term change on the issues affecting their communities.
- Addressing injustice by building the power of their community. For example, through community organising, campaigning, or democratic engagement.
- Lacking the resources to take their vision to the next level.
- Seeking to build connection and resist the politics of division.

Priority will be given to organisations led by people with lived experience of the injustice they are trying to overcome.

### Eligible Expenditure

Funding should be used to help groups win change through community organising, power-sharing, campaigning and democratic engagement.

### Location

UK

### **How To Apply**

To apply, groups must complete a short eligibility questionnaire by 26 February 2023.

The Civic Power Fund Team will review submissions on a rolling basis to determine which applicants are in scope.

If an organisation is deemed in scope, they will be contacted and supported in submitting a Grant Memo.

A Community Action Panel made up of grassroots organisers and campaigners from across the UK will make the final decision about which organisations receive funding in April 2023.

# **Cash for Kids - Cost of Living Grants**

Grants available to charities, community groups and professionals to help disadvantaged children across the UK during the current cost-of-living crisis

# **Background**

Bauer Media operate radio and magazine brands in the UK and worldwide, and Cash for Kids is their UK charity. The charity helps children and young people (up to 18 years old) affected by poverty, neglect or those living with additional needs.

The new Cost of Living Grant scheme supports charities and professionals to provide support to families most in need in their area.

# **Objectives of Fund**

The aim of the new Cost of Living Grant is to provide emergency essentials to support the physical and mental wellbeing of disadvantaged children in the UK.

### Value Notes

A total fund of £1 million is available.

Grants are for £50 per child per household.

# **Match Funding Restrictions**

Match funding is not required.

### Who Can Apply

Professionals within a governing body (e.g. social services, GP, teacher, charity, community group etc.) are eligible to apply on behalf of families in need.

Registered charities or community organisations must have a formal constitution or governance document and safeguarding policy.

### Restrictions

Families cannot apply directly to the Fund.





The beneficiaries must not have been referred to the Cost-of-Living Fund by any other organisation other than the applicant.

### Eligible Expenditure

Costs such as food, clothing (including school uniform) and household energy are supported by the grant but any other item or cost is considered if children's most basic needs are to be met.

Items such as household fuel vouchers, food parcels, food vouchers, toiletries, clothing and wellbeing packs should be provided from the grant.

The 100x Impact Accelerator Programme, a global accelerator open to ventures from around the world, is based at LSE.

# **Objectives of Fund**

100x Impact Accelerator will support two cohorts of 10 social enterprises every year, with 70% of these coming from emerging markets.

The accelerator is looking for scale-up impact organisations that have a proven model, so it can help deliver their next big leap of growth.

Two cohorts of 10 social enterprises will be supported every year.

The purpose of the Fund is to provide small grants to charities and community groups across Scotland who can pass the funding on to families and individuals on low incomes.
