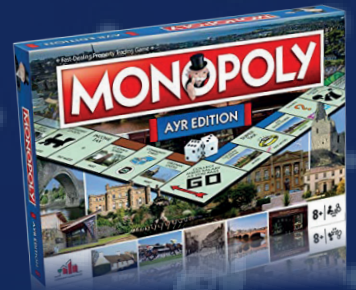

If you need help, we may be able to offer advice on a range of financial help or support, such as discretionary housing payments or ways to maximise your income. This could also include grants being awarded to assist with rent arrears.

# HomeSwapper<sup>®</sup>

## Are you thinking about a Mutual Exchange?

South Ayrshire Council has subscribed to HomeSwapper, the UK's largest online home-swapping platform. Tenants using the HomeSwapper service for a mutual exchange (also known as a home swap) will have the opportunity to swap their home with another council or housing association anywhere in the UK – greatly expanding housing options for South Ayrshire Council tenants.

To ensure you are prepared for moving, you should consider the following before taking the next step towards a mutual exchange:

- What are you looking to achieve through a mutual exchange? (Change in property size, location, proximity to schools, further education establishments, employment, family / friends / supports, social activities, shops, travel links)
- How will you manage and fund the costs of moving home (removal and decorating costs)?
- Have you considered any increase in living costs such as rent charge, council tax, fuel costs, travel costs?
- A mutual exchange may not be progressed if you have tenancy related debt: outstanding rent arrears, former tenant arrears, court expenses or rechargeable repairs
- Is your home and garden in a good condition?
- Have you reported all outstanding repairs issues within your current home?

# HOUSING SERVICES NEWS

## Rent Non - Charging Fortnight 2024

Remember there is a non-charging rental fortnight from Thursday 12th December 2024 until Wednesday 25th December. This means that as long as you are up to date with your rent, you don't need to make a payment for this period.

If you pay by Direct Debit or monthly Standing Order your payments should be made as normal as payments are calculated over the year.

If you get help towards paying your rent as part of your Universal Credit payment, this is also calculated over the year, and you should continue to make your normal monthly rent payment.

If your rent is not up to date, you must continue to pay during the non-charging fortnight to help you catch up with your payments and reduce your rent arrears.

If you are struggling to pay your rent it is important that you contact us right way. Your Housing Officer can offer advice and information to help you manage your rent payments.

Contact us on 0300 123 0900 and select Option 2 then Option 1 and ask for Housing and then select option 2.

## Performance Edition 2023/24

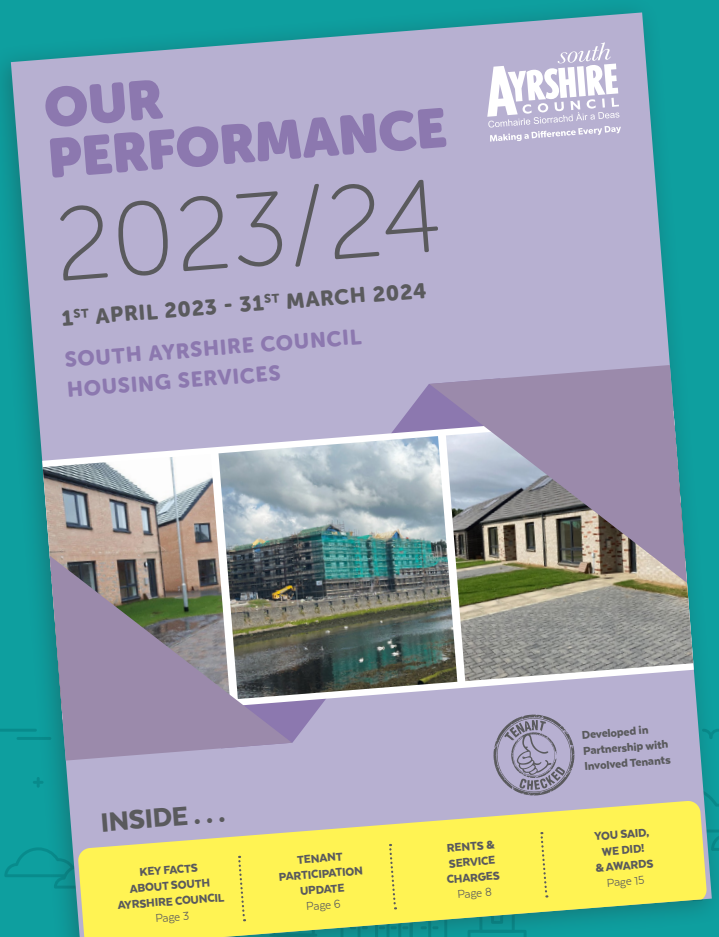
Available now is our Performance Edition 2023/24. The edition provides information on how we have performed as a landlord from 1st April 2023 to the 31st March 2024.

# Tenant Participation (TP) Update

## **Scrutiny Training**

A number of Involved Tenants took part in the refresher Tenant Scrutiny Training that took place over two days in October. This training provided the Involved Tenants with the knowledge and understanding of how to evaluate Council services using the information provided from tenant satisfaction surveys such as the repairs survey returns.

## **Housing Online Project**

Involved Tenants have been helping to test the forthcoming Housing online system. They have been working with staff to make sure the processes are easy to understand and follow for tenants and customers.

The project will see the introduction of more accessible online functions for tenants and those applying for housing and will also help to reduce time spent by officers processing information.

As part of the new system, you will be able to apply online for housing, check your rent records and make payments, and provide us with supporting documents electronically along with some other features. Every household will receive more information and instructions on how to sign up for the new system once it is ready to go live in 2025.

During the testing session tenants were able to input requests into the system, which allowed staff to test the background environment and behind the scenes processes.

## **Tenants Monitoring Group**

At the recent meeting of the Tenants Monitoring Group, Involved Tenants were provided with an overview of the processes and procedures that our Anti-Social Behaviour Team follow when investigating reports. The group regularly receives overviews of different areas of the service, providing Involved Tenants with

a greater understanding of internal processes and procedures throughout the service area.

The group were also recently involved in approving our Annual Assurance Statement for 2024 that is required by the Scottish Housing Regulator.

## **Tenant Participation Strategy 2025 - 2030**

A working group including involved tenants and our Tenant Participation Team are currently working on updating and refreshing our Tenant Participation Strategy for 2025 - 2030. Early in 2025 we will be carrying out a consultation with tenants from across South Ayrshire on the draft updated strategy before it is submitted to the Council's Leadership Panel for consideration. # POWER OF ATTORNEY

In Scotland each year thousands of people will lose capacity to make decisions, whether due to a Stroke, Dementia, other progressive condition or accident.



A power of attorney allows you to nominate a trusted person to support you with financial and welfare decision making if you are no longer able to make these decisions.

# POWER OF ATTORNEY

## What is it?:



A power of attorney is a legal document that allows someone to make decisions on your behalf if you become unable to do so and to support you to manage your finances.



## Why do I need it?

Having a Power of Attorney can give you peace of mind as you know you have the support of a trusted person to make decisions when you are unable to.

## When do I need it?



It is never too early to put a Power of Attorney in place, illness or accidents can happen to any of us. Future planning can reduce stress and worry for you and your family.

# The Scottish Welfare Fund

**A discretionary fund that may be able to help. Are you or your family in a crisis?**

**Are you at risk when setting up or staying in your own home?**

**Help may be available from the Scottish Welfare Fund**

*Respect for, and dignity of, applicants for assistance*

Under the Scottish Welfare Fund, two types of grant are available through local councils. They can help people who are on a low income and are having difficulty because of an exceptional situation or in meeting one-off expenses.

- **Crisis Grants may be provided to qualifying individuals who are facing a disaster or emergency situation, and where there is an immediate threat to the health or safety of that individual or their family.**

- **Community Care Grants may be provided where a qualifying individual needs help to establish or maintain a settled home. For example, individuals who are leaving prison, hospital, residential care, or another institution, or those who are homeless or otherwise living an unsettled way of life.**

**If you are a professional representing a client or service user in need, you can apply to the Scottish Welfare Fund on their behalf with their consent.**

## How can a Crisis Grant help you?

If you're facing a crisis at home such as a fire or flood, or in an emergency situation such as running out of food, a Crisis Grant could help.

Crisis grants can be made in a variety of ways, such as financial help to buy food or pay for heating, or items such as a cooker or furniture following a disaster.



## How can a Community Care Grant help you?

If you're about to leave care to live on your own in the community such as after being in hospital or prison, or face going into care because you don't have the things you need to continue living at home or have been homeless, or living an unsettled life and need help to start a settled home, a Community Care Grant could help.

A Community Care Grant may also be able to help if you're struggling to provide a safe and secure home for your family. For example, you might need help to get essential household items such as a cooker or washing machine.

Community Care Grants are normally provided in the form of goods, for example:

- cookers
- beds
- furniture

## Other Sources of help

The Money Talk Team can support an individual / family to maximise their household income by ensuring they are not paying more for essential goods and services than they need to and that they are getting all the benefits, grants and exemptions (council tax, energy) they are entitled to. Your Local Authority should also be able to refer you to other relevant organisations that are local to your area, who may also be able to provide additional assistance.

The Department for Work and Pensions may be able to offer an Advance or Hardship Payment.

A number of benefits have transferred over to Social Security Scotland. This includes benefits for people on low incomes, disabled people, carers, young people entering the workplace and help for people to heat their homes.

# Fire Safety for tenants with hearing loss

**One in five of the Scottish population are deaf and may not be woken up by a conventional fire alarm system in their home.**

Under new legislation, every home in Scotland must have a standard interlinked fire alarm systems fitted to alert people to any potential danger. The legislation specifies the type, and required location of these.

Specialist fire alarm accessories / alerts are available for those who may not hear a standard alarm.

This includes flashing strobe lights, vibrating pads, vibrating pager alerts and mobile phone alerts, which will alert a person should there be a fire. This ensures that deaf people and those with hearing loss have the same protection from fire as everyone else.

## Who is responsible for providing specialist fire alerts / accessories?

Under the Equality Act 2010, tenants (local authority, housing association and private) can ask their landlord to make specific changes to the property that are needed to avoid the disabled person being at a disadvantage. Appropriate fire alarm alerts / accessories for people who have deafness or hearing loss fit into that category.

The local authority is responsible for installing specialist fire alarm alerts / accessories for deaf or hard of hearing tenants. The tenant does not cover the costs, although some tenants may wish to pay for an upgrade or additional specialist equipment.

The South Ayrshire Sensory Team are available for advice, support or information for people with vision loss and / or hearing loss and for people who are Deaf .

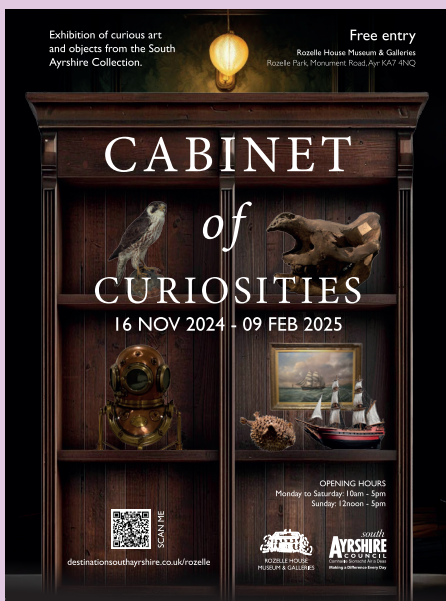

# MULTI SKILLING

Skills shortages, employee productivity, access to appropriate training and attracting new employees into local authority all present critical challenges to our services. One solution that could positively address all these challenges is the enhanced development and wider use of multiskilling.

Multiskilled operatives may have a primary single trade in which they are highly proficient and fully qualified but may also have additional skills so they could be assigned tasks along with their traditional trade descriptions.

Our Property Maintenance team are now starting to look at this way of working and have already spoken to several stakeholders, including Involved Tenants and Unions, on how this would work in the department, new job descriptions have been created along with a matrix on how this will work and all the training requirements of this project.

We do have several stakeholders still to discuss this with and we are hoping to have this carried out shortly after which a paper would be prepared for cabinet approval.

# New Build Updates

## Riverside Place, Ayr

Progress on site is continuing at a fast pace. Intended completion of the project looks set for September

2025. Once completed the development will feature 43, one bedroom properties and 32, two bedroom properties at the site; five of the homes will be fully accessible for wheelchair users.

A number of handovers of completed units including 1, 2, 3, 4 and 6 bedroom properties have taken place over the last couple of months. The site looks set for completion in the early part of 2025 with only a small number of properties remaining to be completed out of the 160 properties as part of this project.

## St Ninians, Prestwick

There are 42 units on site at the former St Ninians Primary School site with several units at their final construction phase. A central green will be formed to provide much needed open space in the local area. The first completions will be ready for handover in the first few months of 2025.

The site consists of 2, 3 and 4 bed family houses, 2 bed cottage flats and within the mix 6 wheelchair accessible units, (which include 2 x 2 bedroom bungalows and 4 x 3 bedroom properties).

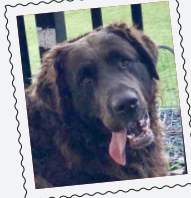
