Minutes of a hybrid webcast meeting of 1 December 2022 at 10.00 a.m.

Chair's Remarks

The Chair

- (1) welcomed everyone to the meeting; and
- (2) outlined the procedures for conducting this meeting and advised that this meeting would be broadcast live.

1. Sederunt and Declarations of Interest.

The Service Lead – Legal and Licensing called the Sederunt for the meeting and having called the roll, confirmed that there were no declarations of interest by Members of the Panel in terms of Council Standing Order No. 17 and the Councillors' Code of Conduct.

2. Minutes of Previous Meeting

The minutes of 3 November 2022 (issued) were submitted and approved.

3. <u>Civic Government (Scotland) Act 1982 – Late Hours Catering Licence Exemption</u> <u>Applications</u>

There was submitted a <u>report</u> (issued) of 11 November 2022 by the Head of Legal and Regulatory Services presenting three applications requesting an exemption from the requirement to obtain a late hours catering licence for a particular occasion which required to be determined by the Panel.

The Service Lead – Legal and Licensing referred to a typographical error within the report advising that the application was for Thursday 22 December and Friday 23 December 2022.

The Panel

Decided:

- to accept the three letters received from Gosschalks Solicitors, attached as Appendix 2 to the report, on behalf of their client Wm Morrison Supermarkets Ltd, all dated 27 October 2022, as applications for exemptions from the requirement to hold a late hours catering licence, in terms of Section 42(5) of the Civic Government (Scotland) Act 1982;
- (2) to grant the applications to Wm Morrison Supermarkets Ltd for exemption from the requirement to hold a late hours catering licence for Morrisons Petrol Filling Station, Duke Street, Troon; Morrisons Petrol Filling Station, Castlehill Road, Ayr; and Morrisons Supermarket, Castlehill Road, Ayr; between 23:00h and 00:00h from Thursday 22 December 2022 to Friday 23 December 2022 inclusive; and
- (3) to impose the South Ayrshire Council late hours catering conditions, under deletion of the word "licence holder" and insertion of the word "applicant" applicable to late hours catering licence, attached as Appendix 3 to the report.

The Service Lead – Legal and Licensing called the Sederunt for the meeting and, having called the roll, confirmed that there were no declarations of interest by Members of the Panel in terms of Council Standing Order No. 17 and the Councillors' Code of Conduct.

2. Exclusion of press and public.

The Panel resolved, in terms of Section 50A(4) of the Local Government (Scotland) Act 1973, that the press and public be excluded from the remaining items of business on the agenda, on the grounds that they involved the likely disclosure of exempt information in terms of paragraph 6 of Part 1 of Schedule 7A of the Act.

3. <u>Civic Government (Scotland) Act 1982 – Taxi Driver Licences</u>

(a) The Panel heard from Police Scotland in relation to the proposed suspension of the licence currently held by Patrick O'Donnell; and from the licence holder and his representative in response.

The Panel

Decided:

- (i) to suspend the licence currently held by Patrick O'Donnell with immediate effect until the expiry of the period of Disqualification Order issued by Ayr Sheriff Court under Section 40B of the Child Support Act 1991 (one year from 21 October 2022) or until the Disqualification Order has been revoked if earlier; and in terms of Paragraph 11(2)(a) of Schedule 1 of the 1982 Act as, in their opinion, the holder of the licence is no longer a fit and proper person to hold the licence; and
- to grant delegated powers to the Service Lead Legal and Licensing, to lift the suspension of the licence, should Police Scotland advise that the Disqualification Notice had been revoked.
- (b) The Panel heard from Police Scotland in relation to the proposed suspension of the licence currently held by Dominic Bennett.
 - **Decided:** in the absence of the applicant, to suspend the licence currently held by Dominic Bennett with immediate effect for a period of six weeks or until a hearing under paragraph 11 of the Act, whichever shall be earlier.
