Minutes of a hybrid webcast meeting held on 9 March 2023 at 10.00 a.m.

Opening Remarks

The Chair welcomed everyone to the meeting and outlined the procedures for conducting this meeting; and advised that this meeting would be broadcast live.

1. Declarations of Interest

There were no declarations of interest by Members of the Board in terms of the Councillors' Code of Conduct.

2. Date of Next Board Meeting

The Chair advised that the next Board meeting would be held on Thursday 20 April 2023 at 10.00 a.m.

3. Minutes of Previous Meeting

The **Minutes** of the Meeting of South Ayrshire Licensing Board of 12 January 2023 (issued) were submitted.

Decided: to approve the Minutes of the previous meeting.

4. Update by Licensing Standards Officer

The Licensing Standards Officer advised:

- (1) that, a significant number of extended hours and occasional licence applications had been received since the January Board reflecting the large number of events and activities planned throughout 2023. The LSO highlighted that this was an example of the change to the way that many people were now socialising, with planned events taking over from a regular weekly outing for some groups.
- (2) that a minimum of 28 days notice is required to process, consult on and grant an occasional licence and this information is detailed in the Board's current policy statement. The LSO explained that unfortunately, there had been a few applicants who had failed to adhere to the time requirement resulting in the inability to proceed with their application. The LSO stated that she would like to remind applicants that applications are unable to be accepted outwith the 28 days' notice period.

- (3) the LSO highlighted the exception in the Licensing (Scotland) Act 2005 for funerals and stated that these applications would continue to be processed immediately upon receipt.
- (4) due to the restrictions of the past few years, the South Ayrshire Local Licensing Forum had not been able to operate in full for some time. However, the LSO said she was pleased to report that the Licensing Board Forum had re-started recently and held a successful meeting last month with members of the Trade and local communities.
- (5) The LSO advised that the Licensing Forum were currently working to fill the vacancies for partner agencies, aiming to have a full representation in the next few months. The LSO noted that the next scheduled meeting of the Licensing Forum is later in March, whereby Forum Members hope to consider a response to the Boards policy statement.

Subject: Revocation of Personal Licences

1. Purpose

To advise members on the revocations of personal licences.

2. Recommendation

To note the terms of the report

3. Background

The Licensing (Scotland) Act 2005 introduced personal licences. It is a condition of the personal licence that (a) the applicant undertakes refresher training within five years of the date of issue of the licence and (b) no later than 3 months after the expiry of five years from the date of issue produces evidence of the training to the Board. Failure to complete either part of the process means that the Board must revoke the personal licence. (Licensing (Scotland) Act 2005 section 87(3))

4. Current Position

Since the last report to the Board, a further 41 personal licences as per appendix 1 have been revoked under delegated powers. All licence holders affected have been advised by post to their last known address of the revocation of their licences. Revoked licence holders can still take refresher training and then reapply for another personal licence although there is a cost of £50 for the new application. (There is no fee payable if the refresher training is completed and intimated to the Board on time.)

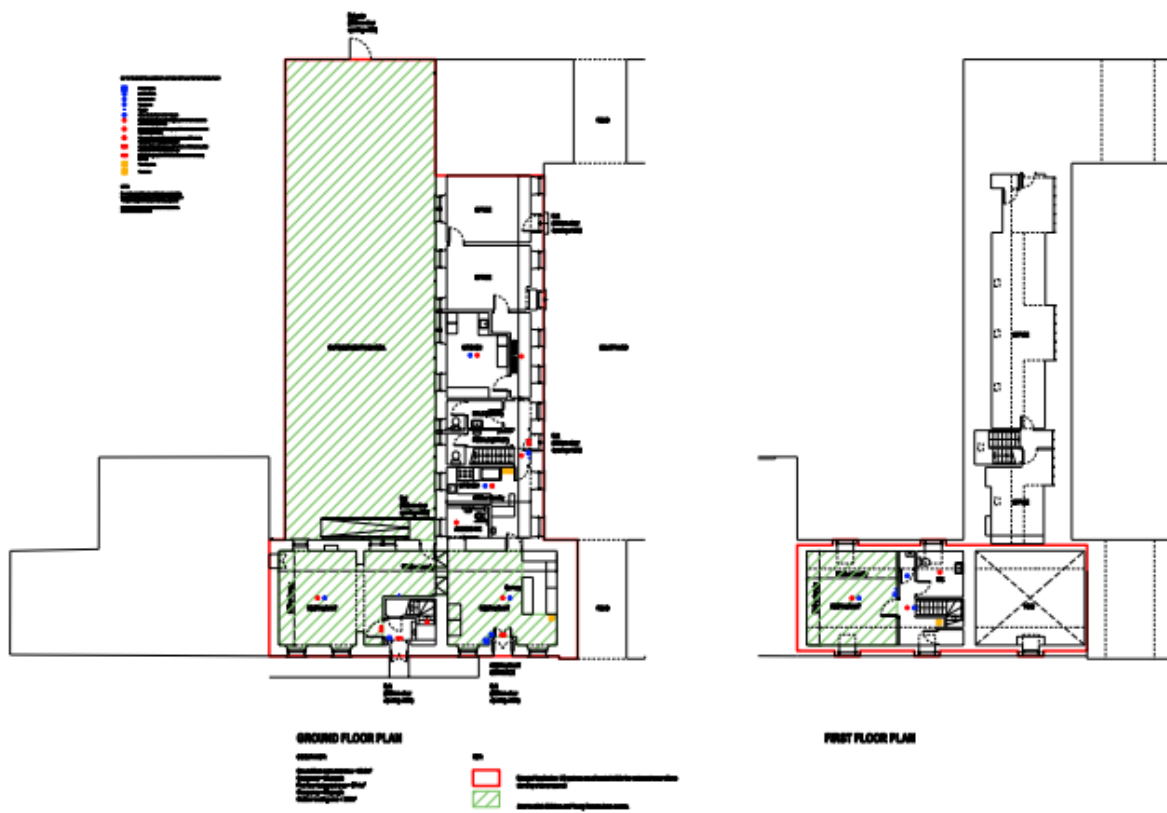

APPLICATION REPORT

1. Background:

An application for a provisional premises licence for a restaurant.

The core hours sought are 10:00- 00:00 daily for on sales only.

The Clock Tower restaurant describes itself as a family friendly bistro/café bar.

The applicant is seeking a capacity of 20 persons on the ground floor and 20 persons on the first floor, which has been agreed with Building Standards.

2. Reports

There have been no objections or representations.

Section 50 Certificate from Planning has been lodged along with the application.

The applicant has provided a disabled access and facilities statement -Appendix 1.

The applicant has provided details of how they will meet the licensing objectives – Appendix 2.

3. **Board Options**

The Board should establish what it considers to be locality. Generally, in this area the Board has considered a radius of 500 metres. There are no premises in that area.

The Board must, in considering and determining the application consider whether any of the grounds for refusal applies and-

(A) if none of them applies, the Board must grant the application, or

(B) if any of them applies, the Board must refuse the application.

The grounds for refusal are—

(a) that the subject premises are excluded premises. Excluded premises are defined as premises used as a garage or which form part of premises which are so used. Premises are used as a garage if they are used for one or more of the following-

(b) the sale by retail of petrol or derv

(c) the sale of motor vehicles, or

(d) the maintenance of motor vehicles

However, premises used for the sale by retail of petrol or derv, or which form part of premises so used, are not excluded premises if persons resident in the locality in which the premises are situated are, or are likely to become, reliant to a significant extent on the premises as the principal source of –

(i) petrol or derv, or

(ii) groceries (where the premises are, or are to be, used also for the sale by retail of groceries).

(C) that the application must be refused under section 25(2), 64(2) or 65(3),

(D) that the Licensing Board considers that the granting of the application would be inconsistent with one or more of the licensing objectives,

(E) that, having regard to—

(i) the nature of the activities proposed to be carried on in the subject premises,

(ii) the location, character and condition of the premises, and

(iii) the persons likely to frequent the premises,

the Board considers that the premises are unsuitable for use for the sale of alcohol,

For this reason the Board may wish the applicant to confirm if tickets are sold in advance and they therefore know the ages of all who will attend or if this is a private event and what systems they have in place to check the ages of those who will attend. This information is important as once the Occasional Licence is granted with the ages as requested, any person who attends outwith those ages would therefore be in breach of the occasional licence.

The reason given for the Occasional Licence is 'welcome drinks for Scottish Grand National' however the start time for the Occasional Licence is after the race meeting has started and the terminal hour is some time after the race meeting has finished. To eliminate any confusion regarding the dates applied for and what is actually taking place on the premises, the following questions were directed to the applicant.

- 1- As the application refers to Welcome Drinks and Canapes, can I ask why you consider the event to be suitable for some ages of children and young people under the age of 17 and what activities there will be for them?
- 2- You have requested a licence from 1pm (I understand the race day will have started by then) and a finish time of 11.45pm (a number of hours after racing finishes so can you please advise the purpose of the hours if it is aimed at people who will be attending the races?)
- 3- Besides Alcohol and canapes can you advise what else is happening?
- 4- Are you applying for the licence for the 2 days?

The applicant was made aware in the email that once this information was received it would allow the required report to be prepared for the grant of the application.

Unfortunately, despite these questions being posed to the applicant on 14th March 2023, at the date of writing we still have no response from the applicant and therefore the Board may wish to decide if it is appropriate to grant this application with the limited information that has been supplied and that doing so will not breach the licensing objective 'Protecting Children and Young People from Harm'.

Gary Welsh – Personal Licence Holder
Occasional Licence Application – 29th to 30th April 2023
Report by Licensing Standards Officer

I refer to the Occasional Licence application made by Gary Welsh who is a personal licence holder. The application refers to a property called 'Wellington House on the Square' which is located in Wellington Square in Ayr and the applicant describes it as a 'Wedding and Events Venue' which has been the subject of a small number of previous occasional licences from this Board and there are a few Occasional Licence applications outstanding that have been lodged within the past few months.

The application describes a 'music festival/ticketed event with snacks and drinks' on Saturday 29th April and Sunday 30th April from 1pm until 11.45pm and the application is not clear if this is a two-day event, although the dates requested suggest that it may be.

In addition to this the applicant has advised on the form that there will be children and young persons aged 10 to 16 years in attendance until the terminal hour.

I did note with interest that the event is restricted to age 10 to 16 and this means that 17 year olds and under 10's will not be permitted. For this reason, the Board may wish the applicant to confirm if all tickets are sold and they therefore know the ages of all who will attend or what systems they have in place to check the ages of those who will attend. This information is important as once the Occasional Licence is granted with the ages as requested, any person who attends outwith those ages would therefore be in breach of the occasional licence.

The reason given for the Occasional Licence is a 'music festival/ticketed event with snacks and drinks', however the applicant has not provided any further details about this music event. I am however aware that it is the same date as the large music festival at the Low Green, however the organisers of that have already confirmed in public forum that they have no connection with any premises in Ayr.

For these reasons and to establish further details in relation to this application, the following questions were directed to the applicant.

- 1- The application refers to a Music Concert/Ticketed Event – please could you provide more information about your concert/event (what type of music, is it live bands, do you have a stage etc)

This information would allow me to comment on the licensing objective 'Preventing Public Nuisance'.

- 2- Can I ask why you are permitting children aged 10 years to 15 years and young people aged 16 to this event? And what you believe makes the event appropriate for them until 11.45pm? Also how are you going to check ages to make sure you are not in breach of the licence and do they have to be accompanied by an adult to purchase a ticket?

This information would allow me to comment on the licensing objective 'Protecting Children and Young People from harm'.

- 3- Are your tickets all sold in advance

4- Are you applying for the licence for the 2 days?

The answer to these questions will help us to assess the general impact in the area on these dates as we are aware of another event that night and an awareness of additional people in the area will allow relevant partners to consider any additional factors to ensure they meet the licensing objective 'Securing Public Safety'.

Unfortunately, despite these questions being posed to the applicant on 14th March 2023, at the date of writing we still have no response from the applicant and therefore the Board may wish to decide if it is appropriate to grant this application with the limited information that has been supplied and that doing so will not breach the aforementioned licensing objectives. Board members will be aware of the high volume of applications that are currently being processed and granted and it is not possible to continually 'chase up' information that has still to be provided by individual applicants.

I refer to the Occasional Licence application made by Gary Welsh who is a personal licence holder. The application refers to a property called 'Wellington House on the Square' which is located in Wellington Square in Ayr and the applicant describes it as a 'Wedding and Events Venue' which has been the subject of a small number of previous occasional licences from this Board.

The application describes a 'pop up restaurant' on Saturday 6th May from 1pm until 11.45pm. In addition to this the applicant has advised on the form that there will be children and young persons aged 10 to 16 years in attendance.

In principle I have no objections to an Occasional Licence for a restaurant and the hours requested meet the Boards current policy, however I did note with interest that the event is restricted to age 10 to 16 and this means that 17 year olds and under 10's will not be permitted. For this reason the Board may wish the applicant to confirm if this is a pre-booked event and they therefore know the ages of all who will attend or what systems they have in place to check the ages of those who will attend. This information is important as once the Occasional Licence is granted with the ages as requested, any person who attends outwith those ages would therefore be in breach of the occasional licence.

Additionally as this is not a 'permanent' venue who will necessarily be registered with our Environmental Health team regarding food preparation and therefore I have requested that the applicant confirms if they have made registered as required.

Unfortunately despite these questions being posed to the applicant on 14th March 2023, at the date of writing we still have no response from the applicant and therefore the Board may wish to decide if it is appropriate to grant this application with the limited information that has been supplied and that doing so will not breach the licensing objectives; Protecting Children and Young People from Harm and Protecting and Improving Public Health.
