Land at Barassie Beach, Troon, nr. Barassie public conveniences Common Good Consultation Feedback

Feedback and response on Statutory Consultation with the Local Community under Section 104 of the Community Empowerment (Scotland) Act 2015, for Community Asset Transfer of land at Barassie shore (near Barassie public conveniences) by 50-year lease to Troon Water Sports Centre (TWSC) SCIO SC047691.

The Common Good Consultation for the land at Barassie Beach, Troon (near to Barassie public conveniences) was open between 9am on Monday 6th February 2023 and 4:30pm on Monday 3rd April 2023. A notice regarding the consultation was erected at the site on Barassie Beach, another was displayed in Troon Library and it was hosted on the South Ayrshire Council website (https://www.south-ayrshire.gov.uk/article/58923/Common-Good-Consultation-Barassie-Beach-Troon). Details of the consultation were circulated to Troon Community Council and to Muirhead Tenants & Residents Group as a known community organisation with a possible interest in the land. Troon ward elected members were also notified.

As detailed in the table below, 126 completed responses were received. All were submitted by individuals and all were positive/supportive of the proposal.

The next stage in the process is for a petition to be submitted to the sheriff court, by South Ayrshire Council, to request authorisation of the proposed lease of Common Good land. That work is underway.
