Minutes of a hybrid webcast meeting held on 23 August 2023 at 10.00 a.m.

Opening Remarks

The Chair welcomed everyone to the meeting, outlined the procedures for conducting this meeting and advised that it would be broadcast live.

1. <u>Declarations of Interest</u>

There were no declarations of interest by Members of the Board in terms of the Councillors' Code of Conduct.

2. Date of Next Board Meeting

The Chair advised that the next Board meeting would be held on Thursday 21 September 2023 at 10.00 a.m.

3. Minutes of Previous Meeting

The Minutes of the Meeting of South Ayrshire Licensing Board of 15 June 2023 (issued) were submitted.

Decided: to approve the Minutes of the previous meeting.

4. Annual Functions and Financial Report

There was submitted (issued) the <u>Annual Functions and Financial Report</u> for approval by the Board.

The Depute Clerk to the Board advised

(1) that the Board required to prepare and publish an annual report on the exercise of their functions including a summary of the decisions made, information on the number of licences held and the annual financial report on the licensing activities;

- (2) that the <u>Annual Functions and Financial Report</u> 2022/23 provided information on how the Board had regard to the statutory licensing objectives and the Statement of Licensing Policy; the exercise of its functions during the period; a summary of the decisions made by or on behalf of the Board during the period; information on the number of licences held and more general information on the running of the Board and its meetings; the ongoing policy review process; and training events held during the year; and
- (3) that the report also provided a statement of the income and expenditure relating to the alcohol function for the period which had shown a small surplus which was in contrast to previous years when the work of the Board had shown an overall deficit, however, for a significant part of the year there had been a vacant post in Licensing Services leading to staff costs being lower than usual which had affected the overall financial position.

Comments were made by Board Members in relation to:

- (a) the Board recognising that it had been another difficult year for the licensed trade, particularly the hospitality venues which had faced periods of lockdown and restricted trading; and commended the efforts of the trade for complying with the licensing objectives and the restrictions imposed due to Covid-19; and
- (b) the recent very successful training event and the hope that there would be another similar event in the near future; and the Licensing Standards Officer advised that the event had been well attended by the licensed trade; and that she was currently liaising with Police Scotland to endeavour to arrange another event.

The Board

Decided: to approve the report.

5. Update by Licensing Standards Officer

The Licensing Standards Officer advised:

- (1) that a number of events and activities had taken place over the summer holiday period at indoor and outdoor venues in South Ayrshire which had benefited from an Occasional Licence; and that applications continued to be received on a regular basis from premises now planning for the forthcoming festive period;
- that most applications were now received within the twenty eight day minimum timescale, therefore, the majority of applications had been accepted and granted;
- (3) that, in the coming month, the Ayr Gold Cup Festival at Ayr Racecourse and the Ayr Show on Ayr Low Green would be taking place with both events benefiting from Occasional Licences for alcohol sales, with considerable discussions having taken place with the organisers and personal licence holders to ensure that the alcohol provision was in line with Board policy and reflected other licences that had recently been granted, in particular in relation to access to Children and Young Persons;
- (4) that, over the past two years in particular, there had been considerable changes to staff in hospitality premises, with many experienced staff leaving the industry for employment elsewhere; and that she was finding that a number of premises had insufficient training records and, in some cases, staff who had not received any mandatory training prior to taking up their post, with this also being evident in the complaints that were being received by the Licensing Section, some of which showed an obvious lack of staff training and awareness;

- (5) that providing trained staff was a requirement of the licence and any premises not adhering to the mandatory conditions of the licence would be reminded of this and ultimately brought to the attention of the Licensing Board:
- (6) that the Board's Statement of Licensing Policy outlined that it 'expects' a personal licence holder to be on the premises at all times and the inclusion of this in the Policy demonstrated that the Board did not expect someone with minimum training to be left in charge of premises; and
- (7) that, as the Licensing Standards Officer and a personal licence holder, she had previously undertaken a project allowing her to provide the minimum two hours training to staff in South Ayrshire, that these sessions had always been provided free of charge and had been very well attended, and she was currently exploring the possibility of offering training again within the next few months to assist the licensed trade to raise standards.

The Chair commented that the licensed trade should be reminded that training was mandatory and the Board took this matter very seriously.

The Board

Decided: to note the Licensing Standards Officer's update.

There was submitted a <u>report</u> (issued) of 9 August 2023 by the Clerk to the Licensing Board advising the Board of the revocation of personal licences.

Police Scotland Licensing Overview

The Violence Prevention and Licensing Co-ordination Unit (VPLCU) sits within Partnerships Prevention & Community Wellbeing based at Dalmarnock Police Station, Glasgow.

The VPLCU upholds the two tier structure for licensing which supports both national and local priorities through service delivery. They have overall responsibility for determining and delivering national licensing strategy and policy, by providing advice, guidance and support to divisional licensing teams as well as undertaking other specialist functions.

The Violence Prevention and Licensing Co-ordination Unit is a specialist department which consists of a small team of officers, based in Glasgow. The officers within the unit work with divisional licensing teams and partner agencies to help shape policy and strategy around the police licensing function. They provide practical and tactical advice to police licensing practitioners, operational officers, supervisors and policing commanders.

The VPLCU seek to ensure that legislation governing the sale and supply of alcohol is applied consistently across the country and all opportunities are taken to stop the illegal or irresponsible sale, supply or consumption of alcohol with the intention of preventing and reducing crime and disorder.

During 2022/2023, from a licensing perspective, our particular focus was on the following;

- Scrutiny of the serious incidents of violence, disorder and antisocial behaviour linked to licensed premises.
- Governance and ongoing development of the National ICT Licensing System, known as "Inn Keeper", to increase the efficiency and effectiveness of liquor and civic licensing administration and management. Police Scotland are currently working on upgrade to the National ICT system to ensure compliance with GDPR legislation.

Each of the 13 Local Policing Divisions have a licensing team responsible for the day to day management of licensing administration, complying with statutory requirements as well as addressing any issues that may arise within licensed premises in their local area.

LICENSING BOARD AREA

The Licensing Board area is policed by South Ayrshire Sub-Division. Chief Superintendent Faroque Hussain is the Local Police Commander who has the responsibility for all day-to-day policing functions.

OPERATION OF THE LICENSING (SCOTLAND) ACT 2005

Introduction

Alcohol pervades across a wide range of issues in our society and, as you know, is often a factor in violence, domestic abuse and anti-social behaviour; incidents that the Police Service of Scotland deals with every day in each area of the country. Therefore, licensed premises are carefully monitored with all incidents in and around such premises scrutinised to ensure compliance with the licensing objectives, resulting in a greater knowledge and understanding of potential problematic premises.

A problem solving approach is implemented in conjunction with the Premises Licence Holder and Designated Premises Managers. Premises that continue to fall below expected standards can be subject of formal police interventions and in some cases, a review being submitted to the Licensing Board.

Ayrshire Divisional Licensing Department utilises the Innkeeper database to highlight monitored and problematic premises, this allows our officers to focus their attention on the premises requiring the most support and attention.

Board Decisions

Application for a Premise Licence

In the South Ayrshire board area during the reporting year, there have been no premises licence objections submitted to the South Ayrshire Licensing Board by Police Scotland.

Application for Review of Licence

In the South Ayrshire board area during the reporting year, there have been no premises licence reviews submitted to the South Ayrshire Licensing Board by Police Scotland.

Variation to a Premise Licence

During the reporting year, there have been no objections to variations of a licenced premise licence submitted to South Ayrshire Licensing Board by Police Scotland.

Personal Licences

Personal licences are carefully considered by Ayrshire Division Licensing in line with policy and legislation before being returned to the local authority. In the reporting year, there have been no personal licence objections submitted to South Ayrshire Licensing Board.

Personal Licence Reviews

During the reporting year, there have been no Personal Licence reviews submitted to South Ayrshire Licensing Board.

Formal Police Interventions

Our focus is to improve the safety and wellbeing of people, places and communities in South Ayrshire by focusing on keeping people safe. This is done by local officers who are proactively identifying and addressing concerns regarding licensed premises at an early stage. Through early intervention and working in partnership with Designated Premise Managers and Premise Licence Holders, areas of concern have been successfully resolved without the requirement for a premises or personal licence review.

These agreements are entered into between Premises Licence Holders and Police Scotland and set out areas in which improvement could be made. Each agreement is monitored and reviewed within a specific timescale to ensure that the necessary improvements have been implemented.

The formal intervention process should result in an improvement in standards and practices. The process also ensures that Police Scotland utilises a fair and evidence based approach prior to pursuing a formal review of a premises licence if agreed terms are not being complied with or if there are recurring issues.

We can report that there have not been any Formal Police Interventions issued within the South Ayrshire Board Area.

PREVENTING THE SALE OR SUPPLY OF ALCOHOL TO CHILDREN OR YOUNG PEOPLE

In South Ayrshire there have been no reports submitted to the Procurator Fiscal for contravention of Section 102 of the Licensing (Scotland) Act 2005, which relates to the sale of alcohol to a child or young person.

Locality Policing and campus officers are exploring the possibilities of returning the Test Purchase Scheme that was previously delivered and was an effective tool to address such issues when they were identified within our communities.

TACKLING SERIOUS AND ORGANISED CRIME

Serious and Organised Crime (SOCG) presents a clear threat to the Ayrshire Licensing trade and legitimate economy. As a result, Ayrshire Division continues to target known criminality in this area as well as attempting to reduce the opportunity for individuals to exploit legitimate licensing opportunities for their own illegitimate means.

Licensing staff work closely with Divisional Intelligence teams to explore intervention opportunities against Serious and Organised Crime Groups.

At this current time, there are 5 Serious Organised Crime Groups being managed by Ayrshire Division with this group having a known interest in a business requiring some form of licence to operate. Not all groups are based in South Ayrshire but they all operate on a pan-Ayrshire basis.

This involvement in the licensing trade is often a direct result of the expertise or experience of an individual from their group in that business sector, and/or the chosen business, providing an ability to launder criminal proceeds.

Officers in South Ayrshire continue to carry out targeted premises visits whenever possible to ensure that all license conditions are being complied with. Such visits will also involve a range of partner agencies including;

HMRC, DVSA, DVLA, Scottish Power, SEPA, South Ayrshire Council, SIA and others.

Within South Ayrshire, continued scrutiny of problematic premises has in the past had positive results. Licensed premises throughout Ayrshire usually positively engage

with Police by not only reporting incidents that occur within the Licensed Premise, but incidents that occur out with the premise, ensuring public safety.

PROPOSED ACTIVITY FOR THE YEAR AHEAD

South Ayrshire Sub-Division will continue to focus on "Keeping People Safe" and will work collaboratively with the licensed trade, partners and local communities to improve standards and compliance across the licensed trade and actively targeting;

- excess alcohol consumption
- vulnerability due to excess alcohol consumption
- sale and supply of alcohol to children and young people
- incidents of crime and offending connected to sale of alcohol

Operation Inver

Operation Inver is a partnership approach to ensure a focussed and proportionate response to support the night time economy in South Ayrshire.

The overarching objective during this time will be to Keep People Safe. The following strategy is implemented for this operation:

- Maximise the safety of the public.
- Minimise disruption to the local communities.
- Ensure public order is maintained, addressing alcohol related violence and antisocial behaviour, particularly in and around licensed premises.
- Ensure licensed premises comply with the current legislation.
- Ensure positive and negative interactions with licensed premises are accurately logged.

Officers are tasked with specific duties including visits to licensed premises to ensure that licensing legislation and responsibilities expected by managers and staff as contained within their license is complied with, and that any instances of anti-social behavior in and around licensed premises is dealt with accordingly.

In engaging members of the public the policing style adopted is friendly and engaging whilst robustly dealing with any instances of anti-social behaviour.

Operation Inver is further enhanced on Saturday nights with the deployment of Taxi marshals, Street pastors and St Andrews Ambulance.

FOCUS ON VULNERABILITY AND DUTY OF CARE IN THE NIGHT TIME ECONOMY – Bystander Training.

Divisional Licensing staff carried out Bystander training in South Ayrshire in May 2022. This is training offered to Licensed premises to raise the awareness of preventing incidents of vulnerability and related crime, promoting safety by identifying the signs

of vulnerability at the earliest opportunity, minimising the risk to themselves or members of the public by:

- Understanding what Vulnerability is
- Recognise the impact factors
- Identify those who may be vulnerable
- Understanding what our duty of care is
- Practical information

IT'LL COST YOU CAMPAIGN

The 'It'll cost you' alcohol proxy purchase campaign was promoted in South Ayrshire. The aim of this campaign was to raise awareness of the consequences of proxy purchase and

- Reduce the number of proxy purchases of alcohol for under 18's
- Reduce crime and antisocial behaviour
- Make our communities safer
- Protect children and under 18's from harm

This was to target

- 1. Adult's (anyone over the age of 18) including parents, older siblings, friends and members of the general public, who under 18's may approach to buy alcohol for them.
- 2. Under 18's children need to understand that not only are there serious consequences for the adults they ask to make a purchase for them, their actions may inadvertently place them in dangerous or vulnerable situations.

The Licensing Department has signed up to continue to promote this campaign in 2023 along with the Police Scotland Youth Volunteers.

To conclude we would like to thank you for your continued support during what has been a challenging year for all. We have all had to adapt to a new way of working and ever changing circumstances which has been embraced by all.

We look forward to a safe and healthy 2023/2024.



I refer to the Occasional Licence application made by Gary Welsh who is a personal licence holder. The application refers to a property called 'Wellington House on the Square' which is located in Ayr and members may recall the applicant appeared at a previous Board meeting earlier in the year.

The application describes a 'Halloween Event' on both Monday 30th and Tuesday 31st October from 6pm until 10pm.

The applicant has advised on the form that there will be children and young persons in attendance 'with family members', however he does not state the ages for this.

Additionally the applicant has indicated that the purpose of the event is a 'Halloween haunted house for families' and advises that additional activities other than the sale of alcohol will be the 'sale of fun refreshments, such as Halloween drinks and food for children & attending parents'.

As the event is being billed as a 'family event' and a haunted house, it is clearly being designed to appeal to children and young people and less likely to be for over 18's who do not have children. For this reason the Board may wish to consider whether grant of the application would be in accordance with the licensing objective 'Protecting Children and Young People from Harm'.

The Board are in the process of updating their policy and have advised of their reluctance to grant an occasional licence to an event designed primarily for 'children and young people'.

The applicant has not been in touch with the LSO to discuss this application despite the Boards encouragement to do so previously and I am therefore only in a position to comment on the information provided on the application.

I refer to the Extended Hours application submitted for the above premises which is situated in Templehill in Troon.

The application requests a terminal hour of 3.30am on the evening of Thursday 5th, Friday 6th and Saturday 7th October (extending into the morning of Sunday 8th October) and the application refers to the 'Annual Ayrshire Real Ale Festival', which is described by the applicant as 'an event of local or national significance'. The core hours for these premises currently extend to 2.30am on a Thursday, Friday and Saturday so this application is to permit an additional trading hour.

I am aware that premises in South Ayrshire have traditionally enjoyed extended hours for events happening locally as they anticipated a larger crowd in the area and people staying later as many of these events attracted visitors from out with the area. Examples of these already this year include the Scottish National, the Pavillion Festival and The AyrShow, and applicants described the reason for the extended hours as 'an event of local or national significance'.

This particular application comes from an experienced operator who is aware of the Board's policy in relation to extended hours and has carefully considered the reasoning behind the request for additional trading.

The Ayrshire Real Ale Festival has operated in Troon for a number of years and Mr Morrison the applicant has been a consistent part of the promotion of this event since its inception. The applicant premises stocks the most amount of cask ale in the town (with a total of 5 pumps) and therefore expects to be a popular venue as usual throughout the festival weekend.

I am aware that these premises have enjoyed additional hours the last few years for this annual festival and no complaints or adverse comments were received by Licensing as a result. I can confirm that these premises only have permission for under 18's to attend until 8pm unless in the event of a private function when they may stay until close. The licence holder understands this is not a private function and therefore if the Board are minded to grant the additional hour then under 18's will not be on the premises beyond 8pm as per the application granted by the Board in 2022.

Considering the above information and having checked the media surrounding the event I am satisfied it meets the criteria of 'a special event to be catered for in the premises'. Whilst this event is being advertised as an 'over 18's only' event, it should be noted that the date is during the October school holidays and therefore the operator expects people may travel from further afield to attend the event due to it being during the holiday period.

Although the applications are separate, the Board should note that this applicant has applied for extended hours at these premises for 'Halloween' on Tuesday 31st October for a fully immersive Halloween themed event. Being aware that the Board stated in their report in 2020 that they would be willing to consider one day for Halloween, I contacted the applicant who has advised that whilst both events are taking advantage of the time of year and offering a 'Halloween theme' they are different offerings.
